Subject:- Regarding widening of territorial jurisdiction of Gram
Nyayalayas Bilsa, Budaun.

Respected Sir,

In the compliance of above referred letter I hereby propose suggestions on the captioned subject as under:-

1. **Part 1 of the First Schedule** be amended by adding the words "*all offences triable by the Judicial Magistrate-1 Class.*"
2. *There is of clarity with respect to nature of reliefs which can be granted by Gram Nyayalayas by invoking specific provisions of Specific Relief Act. 1963 Order-XXXIX of Civil Procedure Code, 1908. Therefore, Sec 13 read with Part 1 of Second Schedule of Gram Nyayalayas Act, 2008 be amended by adding the words "Relief under specific provisions of Specific Relief Act, 1963 and Order-XXXIX of Civil Procedure Code 1908 can be granted by Gram Nyayalayas while adjudicating Civil disputes in the interest of justice."*
3. *Jurisdiction of Gram Nyayalaya mentioned under the under Entries (i-iv) of Part II of First Schedule of the Gram Nyayalaya Act. 2008 overlaps with Jurisdiction exercised by the Labour Courts. Therefore, specific provision should be laid down vide amendment under the captioned act for adjudication of matters mentioned under Entries (i-iv) of Part II of First Schedule of the Gram Nyayalaya Act, 2008.*
4. There is negligible filing of Civil Suits at Gram Nyayalayas due to restrictive nature of subject matters mentioned under the Part 1 of Second Schedule of the Gram Nyayalayas Act. 2008. **Sec 13 read with Part 1 of Second Schedule** of Gram Nyayalayas Act. 2008 be amended by adding the words "*All matters of civil nature having pecuniary jurisdiction of Rs 25,000/- is to be adjudicated by Nyayadhikari at Gram Nyayalayas.*"
5. There is a need to have clarity with respect to territorial jurisdiction of Gram Nyayalayas in Criminal matters.
6. There is general reluctance in compliance of orders of the Gram Nyayalayas by Police and other administrative authorities. Therefore stringent and specific power be conferred to Gram Nyayalayas.
