

Order

A report/letter No. मूफिओओ/एओओओ/कोविड-19/2020-21 dated 06.07.2020 has been received from Chief Medical Officer, Bareilly on 06.07.2020 at 10.30 P.M. through whatsapp, as per the report/letter, Sri Pawan, Class IV employee, District Court, Bareilly has been tested Positive Corona Virus Contagion.

Vide his report Chief Medical Officer, Bareilly has opined for two days closure of Civil Courts, Bareilly.

Hon'ble Court vide letter No. 1117/LXXXVII-CPC/ eCourts/ Allahabad/ dated 03.06.2020 regarding Mechanism/Modalities for opening of Civil Courts subordinate to Hon'ble High Court in para 15 has provided as follows:

"Where the District Administration/CMO concerned is of the opinion that the District/Outlying Court Campus should be closed for a particular period and/or the District Judge is of the opinion that the District Court/Outlying Court should be closed for particular period, then the District Court/Outlying Court may be closed for the said period and an intimation mentioning the specific reasons may be sent to Allahabad High Court".

Opinion of Chief Medical Officer, Bareilly justified.

In view of the above in my opinion reason for closure is necessary.

Hence in compliance of mandate issued in para No. 15 of Hon'ble Courts letter No. 1117/LXXXVII-CPC/eCourts/Allahabad/dated 03.06.2020 for complete sanitization of District Court campus, all the Courts at Head quarter are closed for 48 hours (i.e. 07.07.2020 and 08.07.2020) meanwhile complete sanitization of Court campus be done under supervision of Sri Sunil Kumar Verma, Spl. Judge (SC/ST Act), Bareilly, Sri Satya Deo Gupta, Addl. District & Sessions Judge Court No. 3, Bareilly and Sri Yash Pal Singh, Chief Judicial Magistrate, Bareilly and submit report by 08.07.2020.

**Bails, release and urgent matters fixed for 07.07.2020 are fixed for 09.07.2020 and fixed for 08.07.2020 are fixed for 13.07.2020.**

**Cases fixed for 07.07.2020 are fixed for 07.08.2020 and cases fixed for 08.07.2020 are fixed for 10.08.2020 for hearing.**

Information be sent to the Hon'ble High Court and also be uploaded on the official website of District Court, Bareilly.

A list of employees who have come in contact with Sri Pawan be sent to Chief Medical Officer, Bareilly for Covid testing. Employees are advised to quarantine/ isolate themselves.

Inform all concerned accordingly.


