Order

Sri Ghan Shyam Sharma, President, Bar Association, Bareilly has informed on telephone that Sri Surendra Pandey S/o Sri Sewa Ram practicing Advocate in District Court, Bareilly has been tested Positive Corona Virus Contagion. He has also informed that Sri Surendra Pandey, Advocate has appeared in different Courts and offices.

The Chief Medical Officer, Bareilly has also confirmed vide his report/ letter No. मु0चि0अ0/एस0टी0/कोविड-19/2020-21/2429 dated 22.07.2020 that Advocate Sri Surendra Pandey is tested Corona positive.

The Chief Medical Officer, Bareilly has opined for two days closure of Civil Courts, Bareilly.

Hon'ble Court vide letter No. 1117/LXXXVII-CPC/ eCourts/ Allahabad/ dated 03.06.2020 regarding Mechanism/Modalities for opening of Civil Courts subordinate to Hon'ble High Court in para 15 has provided as follows:

"Where the District Administration/CMO concerned is of the opinion that the District/Outlying Court Campus should be closed for a particular period and/or the District Judge is of the opinion that the District Court/Outlying Court should be closed for particular period, then the District Court/Outlying Court may be closed for the said period and an intimation mentioning the specific reasons may be sent to Allahabad High Court".

Opinion of Chief Medical Officer, Bareilly is justified.

In view of the above in my opinion reason for closure is necessary.

Hence in compliance of mandate issued in para No. 15 of Hon'ble Courts letter No. 1117/LXXXVII-CPC/eCourts/Allahabad/dated 03.06.2020 for complete sanitization of District Court campus, all the Courts at District Head quarter **are closed for 48 hours (i.e. 22.07.2020 and 23.07.2020)** meanwhile complete sanitization of Court campus be done by District Administration under supervision of Covid Committee, District Court, Bareilly and submit the report by 23.07.2020.

Bails, release and urgent matters fixed for 22.07.2020 are fixed for 29.07.2020 and fixed for 23.07.2020 are fixed for 30.07.2020.

Anticipatory bails fixed for 22.07.2020 are fixed for 31.07.2020 and fixed for 23.07.2020 are fixed for 04.08.2020.

And Other cases fixed for 22.07.2020 are fixed for 24.08.2020 and cases fixed for 23.07.2020 are fixed for 25.08.2020 for hearing.

Information be sent to the Hon'ble High Court and also be uploaded on the official website of District Court, Bareilly.

A list of employees who have come in contact with Sri Surendra Pandey be sent to Chief Medical Officer, Bareilly for Covid testing. Employees are advised to quarantine/ isolate themselves.

Letter be also sent to President, Bar Association, Bareilly to send a list of Advocates, who have come in contact with Advocate Sri Surendra Pandey, to Chief Medical Officer, Bareilly for Covid testing.

Inform all concerned accordingly.
