ORDER

It has came to my notice that some Advocates and some employees of this judgeship have been tested COVID-19 positive. Chief Medical Officer, Etah vide his letter no. C.M.O./Covid-19/report/2021/5351, dated: 22nd April, 2021 informed that Sri Ishtiyaq Ahmad, Clerk, Sri Sanjay Yadav and Sri Thakur Singh both Stenographers of this Judgeship have been found COVID-19 positive during antigen test. It is recommended by Chief Medical Officer, Etah that District & Sessions Court, Etah be closed on 23rd April, 2021 for intense sanitisation work.

In the above circumstances, I am also of the opinion that District & Sessions Court, Etah be closed on 23.04.2021 for intense and complete sanitisation of whole Court campus as well as campus of Collectorate Bar Association, Etah.

Hon'ble High Court in Para No.-08 of Letter No. 1941/LXXXVII-CPC/e-Courts/Allahabad/dated:05 April, 2021 has directed that:-

"Where the District Administration/ CMO concerned is of the opinion that the District/Outlying Court Campus should be closed for a particular period and/ or the District Judge/ Principal Judge, Family Court, Presiding Officer, Commercial Court/Land Acqui. Rehab. & Resettlement Authority/Motor Accident Claims Tribunals concerned is of the opinion that the concerned Court/Court Campus should be closed for particular period, then such Court/Court Campus may be closed for the said period and an intimation mentioning the specific reasons may be sent to Allahabad High Court."

Upon consideration of opinion/recommendation of Chief Medical Officer, Etah and in the circumstances as well as



the directions of Hon'ble High Court for complete satisfactory and intense sanitisation of the Civil Court and Collectorate Bar Association, Etah premises to prevent the spread of COVID-19, the District Court Campus shall remain closed on 23.04.2021.

During this period, complete sanitisation of Court campus and the campus of Collectorate Bar Association, Etah be thoroughly done under the supervision of Central Nazir. Report be submitted by 24.04.2021.

All the Presiding Officers are accordingly directed to display the cause list of listed cases of 24th April, 2021 on their notice board and also on CIS.

The Chief Judicial Magistrate, Etah is directed to make necessary arrangements for Remand work, similar as routine holidays.

The daily statements/necessary administrative work shall be performed as per requirement at the camp office.

Copy of this order be sent to the District Magistrate, Etah, Senior Superintendent of Police, Etah, Jail Superintendent, Etah, D.G.C. (Crl.), Etah, D.G.C. (Civil), Etah and Senior Prosecution Officer, Etah for information.

Copy of this order be sent to Executive Officer of Nagar Palika Parishad, Etah for necessary compliance.

Copy of this order be sent to the daily newspapers for publication.

Copy of this order be sent to Collectorate Bar Association, Etah for information.

Information be sent to Hon'ble High Court and also be uploaded on the Official website of District Court, Etah.

Inform all concerned accordingly and a copy of this order be also pasted on the notice board of Court Campus.
