Order No. 127/2021 (Administrative)

The sanitization committed to this judgeship was directed to ensure complete sanitization to the court premises with co-ordination to the District Administration and Chief Medical Officer Barabanki on information of District Bar Association, Barabanki vide letter no. 1106 dated 02.04.2021 in regard to Covid Positive practicing lawyer Sri Mohd Naushad Advocate admitted to the Appollo Hospital and Covid Positive home quarantine Advocate Sri Ram Naresh Verma.

An information vide letter no. 1108 dated 03.04.2021 has again been furnished by the District Bar Association, Barabanki regarding death of Covid patient practicing lawyer Sri Mohd Naushad Advocate.

Consultation made with the District Administration and Chief Medical Officer Barabanki to take necessary steps for complete sanitization of entire court premises including the lawyer chambers and Closure of Courts. The Chief Medical Officer vide letter no. 19/2020 date in 03.04.2021 (copy enclosed) has advised for closure of one day. Entry of the litigants and lawyers will not be appropriate during sanitization. Closure of the Civil Court is quite essential as preventive measure to the Covid-19 spread in compliance of guidelines issued by the Hon'ble High Court vide letter no. 1687/LXXXVII-CPC/e-Courts/Allahabad Dated: 18.12.2020.

Keeping in view the report submitted by the Chief Medical Officer Barabanki and request made by the District Bar Association Barabanki, the committee shall ensure co-ordination with District Administration and Chief Medical Officer for complete sanitization to the Civil Court premises including the court rooms, offices and lawyer chambers. Compliance of guidelines issued by Ministry of Home Affairs (MHA), Ministry of Health, Hon'ble Apex Court and Hon'ble High Court, be ensured in letter and spirit.

The Civil Court Barabanki shall remain closed today on dated 03.04.2021 (Saturday) to ensure complete and effective sanitization to the entire Court premises in compliance of para-3 to the guidelines issued by the Hon'ble Court vide letter no. 1687/LXXXVII-CPC/e-Courts/Allahabad Dated: 18.12.2020.

Following parent Courts and Courts dealing with special jurisdiction shall take up the urgent matters virtually through Video Conferencing-

- a) Court of the Session Judge
- b) Addl. District & Sessions Judge, Court No. 01
- c) Special Judge SC/ST Act
- d) Special Judge EC Act
- e) Special Judge POCSO Act
- f) Courts dealing with cases of Gangster Act & NDPS Act
- g) Chief Judicial Magistrate
- h) Civil Judge (Sr. Div.)
- i) Civil Judge (Jr. Div)
- j) Civil Judge (Jr. Div), Ramsanehighat, Barabanki

Chief Judicial Magistrate, Barabanki, to make necessary arrangement in regard to remand of accused U/s 167 CrPC as per usual holiday practice and Sri Nitynand Shrinet, Special Judge SC/ST Act shall discharged the remand for under trial prisoners regarding all the Sessions Courts.

The Outlying Court of Civil Judge (Jr. Div.) Haidergarh Barabanki, Gram Nyayalaya Sirauli Gauspur and Ramnagar shall function as usual.

The Judicial Officers & the Chief Administrative Officer to take necessary steps for attendance of minimum number of Officials to discharge the Official function, updation and virtual hearing.

The Presiding Officers shall fix category wise general dates in listed cases (e.g. arguments, evidence, appearance, charge, written statement, issues and direction for expeditious disposal). The Judicial Officers and officials shall ensure updation of the date fixed.

Let the information be furnished to the Hon'ble Court for kind perusal forthwith and inform all concerned.
