As per report submitted by the Chief Medical Superintendent, Kanpur Dehat to the District Magistrate Kanpur Dehat vide letter no. Ka. De./Ji. Chi./Administration/2021/26-3 dated 12.04.2021, the sample of Sri Bhagat Singh, Civil Judge (S.D)/F.T.C, was collected on 09.04.2021 in terms of id No. — KNDN0028659270. The above said Sri Bhagat Singh, Civil Judge (S.D)/F.T.C, is reported to be found corona positive on Antigen Test basis. The Chief Medical Superintendent has suggested the closure of the court campus for 48 hours to conduct sanitization work in view of guidelines of Hon'ble High Court.

A Letter addressed to the undersigned by Sri Rahul Verma, Junior Assistant, A.D.J, Court No. -1, Kanpur Dehat informing that he is declared corona positive on the basis of sample collected on 09.04.2021. He has also enclosed a certificate of Chief Medical Officer, Kanpur Dehat. (Letter no. Ka. De./Mu. Chi. Aa./Praman Patra/201201/1841 dated 12.04.2021, case id – KNDN 0028489164).

In view of Hon'ble Courts' letter no. 1941/LXXXVII-CPC/e-Courts/Allahabad dated 05.04.2021 regarding "Guidelines for functioning of District Courts/Tribunals, keeping in view the increasing cases of COVID-19 in Districts." Hon'ble High Court in **para 8** has provided as follows.

"Where the District Administration/CMO concerned is of the opinion that the District/Outlying Court Campus should be closed for a particular period and/or the District Judge/Principal Judge, Family Court, Presiding Officer, Commercial Courts/Land Aqui, Rehab & Resettlement Authority/Motor Accident Claim tribunals concern is of the opinion that the concern Court/Court campus should be closed for particular period, then Such Court/ Court campus may be closed for the said period and an intimation mentioning the specific reason may be sent to Allahabad High Court."

Hence, on consideration of above mentioned letters of Chief Medical Superintendent, Kanpur Dehat and Sri Rahul Verma, Junior Assistant, A.D.J, Court No. -1, Kanpur Dehat and also in compliance of mandate contained in para 9 of Hon'ble Courts letter no. 1941/LXXXVII-CPC/e-Courts/Allahabad dated 05.04.2021 regarding complete sanitization of court campus, it is hereby directed that, all the courts at the District Court Campus, Mati, Kanpur Dehat including outlying court of Bhoganipur (Presently functioning at District Headquarter at Mati, Kanpur Dehat), shall remain closed for 48 hours (i.e 13.04.2020 & 14.04.2021). The outlying court of Ghatampur shall remain functional as usual.

Meanwhile complete sanitization of court campus be done under supervision of O/c Nazarat Sri Abhishek Kumar Chaturvedi, Addl. District & Sessions Judge/F.T.C-I and Sri Kamal Kant Gupta, In-charge Chief Judicial Magistrate. They will submit joint report by evening of 14.04.2021. One Junior/Senior Assistant of all the Courts shall remain present on these days (i.e 13.04.2020 & 14.04.2021) for getting the sanitization work done in their court rooms, Offices & Chambers. Central Nazir & other essential staff of Nazarat will follow the instructions accordingly, for sanitization.

The cases fixed on 13.04.2021 & 14.04.2021 excluding Bail Application for D.J/All A.D.J.s /Civil Judge (Sr. Div.) cadre/ Civil Judge (Jr. Div.) cadre is hereby fixed en mass on 11.05.2021 & 12.05.2021 respectively.

The cases pertaining to all Magisterial Courts (only for Criminal Cases) is hereby fixed en mass on 25.05.2021 & 26.05.2021 respectively.

Information be sent to the Hon'ble High Court Allahabad and also be uploaded on the official website of District Court, Kanpur Dehat.

Inform all concerned accordingly.
