

Order No. - 115 dated: 21.04.2021

ORDER

As per report submitted by the Chief Medical Officer, Kanpur Dehat to the District Magistrate Kanpur Dehat vide letter no. Mu.Chi.A./Covid-19/2021-22/1940 dated 21.04.2021, the sample of Sri Sudhakar Rai, 3rd Addl. District Judge/Special Judge (DAA), Kanpur Dehat was collected on 20.04.2021 in terms of id No. – KNDN0030696342. The above said Sri Sudhakar Rai, 3rd Addl. District Judge/Special Judge (DAA), Kanpur Dehat, is reported to be found corona positive on Antigen Test basis. The Chief Medical Officer has suggested the closure of the court campus for 48 hours to conduct sanitization work in view of guidelines of Hon'ble High Court.

In view of Hon'ble Courts' letter no. 1941/LXXXVII-CPC/e-Courts/Allahabad dated 05.04.2021 regarding "Guidelines for functioning of District Courts/Tribunals, keeping in view the increasing cases of COVID-19 in Districts." Hon'ble High Court in **para 8** has provided as follows.

"Where the District Administration/CMO concerned is of the opinion that the District/Outlying Court Campus should be closed for a particular period and/or the District Judge/Principal Judge, Family Court, Presiding Officer, Commercial Courts/Land Aquai, Rehab & Resettlement Authority/Motor Accident Claim tribunals concern is of the opinion that the concern Court/Court campus should be closed for particular period, then Such Court/ Court campus may be closed for the said period and an intimation mentioning the specific reason may be sent to Allahabad High Court."

Hence, on consideration of above mentioned letter of Chief Medical Officer, Kanpur Dehat and also in compliance of mandate contained in **para 9** of Hon'ble Courts letter no. 1941/LXXXVII-CPC/e-Courts/Allahabad dated 05.04.2021 regarding complete sanitization of court campus, it is hereby directed that, **all the courts at the District Court Campus, Mati, Kanpur Dehat including outlying court of Bhoganipur (Presently functioning at District Headquarter at Mati, Kanpur Dehat), shall remain closed for 48 hours (i.e 22.04.2020 & 23.04.2021). The outlying court of Ghatampur shall remain functional as usual.**

Meanwhile, complete sanitization of court campus be done under supervision of O/c Nazarat Sri Abhishek Kumar Chaturvedi, Addl. District & Sessions Judge/F.T.C-I and Sri Shiva Nand, Chief Judicial Magistrate, Kanpur Dehat. They will submit joint report by evening of 23.04.2021. One Junior/Senior Assistant of all the Courts shall remain present on these days (i.e 22.04.2020 & 23.04.2021) for getting the sanitization work done in their Court Rooms, Offices & Chambers. Central Nazir & other essential staff of Nazarat will follow the instructions accordingly, for sanitization.

The cases fixed on 22.04.2021 & 23.04.2021 excluding Bail Application for D.J./All A.D.J.s /Civil Judge (Sr. Div.) cadre/ Civil Judge (Jr. Div.) cadre is hereby fixed en mass on 20.05.2021 & 21.05.2021 respectively.

The cases pertaining to all Magisterial Courts (only for Criminal Cases) is hereby fixed en mass on 03.06.2021 & 04.06.2021 respectively.


The Bail Applications fixed on 22.04.2021 & 23.04.2021 for All Courts is hereby fixed en mass on 29.04.2021 & 30.04.2021 respectively.

Remand/urgent work related to all the Sessions Courts shall be done by Sri Nijender Kumar, AdJ/FTC-II (14th Finance Commission), Kanpur Dehat for the dates on which the courts are closed, as per holiday practice.

Remand/urgent work related to all the All Magistrate Courts shall be done by Sushri Diksha Yadav, Judicial Magistrate-II, Kanpur Dehat for the dates on which the courts are closed, as per holiday practice.


