Order No. 05/DJKD dated 11.01.2022

ORDER.

As per report submitted by the Chief Medical Officer, Kanpur Dehat to the District Judge, Kanpur Dehat vide letter no K.D./Mu.Chi.Aa./covid-positive case/2022/212 dated 11.01.2022, the sample of Four(04) Class-III employees of Kanpur Dehat Judgeship has been collected today i.e. 11.01.2021 and reported to be found Corona positive on Antigen Test basis. The Chief Medical Officer has suggested the closure of the court campus for two(02) days to conduct sanitization work in view of guidelines of Hon'ble Court.

In view of Hon'ble Court's letter no. letter No. 2423/LXXXVII-CPC/e-Courts/Allahabad dated January 09, 2022 regarding functioning of District Courts, Hon'ble Court in point 04 has provided as follows:

“ That if the District Magistrate / Chief Medical Officer of a concerned district is of the opinion that the District / Outlying Court Campus should be closed for a particular period due to COVID-19, then District Court / Outlying Court may be closed for the said period.”

Hence, on consideration of above mentioned letter of Chief Medical Officer, Kanpur Dehat and in compliance of mandate contained at point 04 of Hon'ble Court's letter no. letter No. 2423/LXXXVII-CPC/e-Courts/Allahabad dated January 09, 2022 above regarding complete sanitization of court campus, it is hereby directed that, **all Courts at District Court campus, Mati, Kanpur Dehat including outlying court of Bhognipur (functioning at District Headquarter at Mati, Kanpur Dehat), shall remain closed for two days (i.e. 12.01.2022 & 13.01.2022). The outlying court of Ghatampur shall remain functional as usual.**

Meanwhile, complete sanitization of court campus be done under supervision of O/c Nazarat Sri Abhishek Kumar Chaturvedi, Addl. District Judge/F.T.C.-I. He will submit the report, accordingly. At least one staff from each court/offices shall remain present on these days (i.e. 12.01.2022 & 13.01.2022) for getting the sanitization work done in their court, rooms, Offices & Chambers. Central Nazir & other essential staff of Nazarat will follow the instructions accordingly, for sanitization.

The cases fixed on 12.01.2022 & 13.01.2022 (excluding Bail applications) for D.J./All A.D.J. are hereby fixed on 02.02.2022 & 03.02.2022 respectively. Dates of cases fixed for final arguments shall be decided by the Court concerned individually.




The cases fixed on 12.01.2022 & 13.01.2022 for Civil Judge (Sr. Div.) cadre/ Civil Judge (Jr. Div.) cadre are hereby fixed on 02.02.2022 & 03.02.2022 respectively. Dates of cases fixed for final arguments shall be decided by the Court concerned individually.

The cases pertaining to all Magisterial Courts (only for Criminal cases) are hereby fixed on 16.02.2022 & 17.02.2022 respectively.

Similarly, the remand work for Session Courts/ additional session Courts shall be performed by **Sri Nijendra Kumar, Addl. District Judge/F.T.C.-II** on 12.01.2022 & 13.01.2022, through video conferencing. The Chief Judicial Magistrate, Kanpur Dehat is directed to issue separate order assigning duty to do Remand work related to Magisterial Courts on 12.01.2022 & 13.01.2022, as per holiday practice.

Information be sent to Hon'ble High Court, Allahabad and also be uploaded on the official website of District Court, Kanpur Dehat.

Inform all concerned accordingly.
