COVID-19 Committee of District Court, Lucknow by virtue of report dated 11.08.2020 has submitted that since Shri Atul Kumar Trivedi, Advocate, practicing in District Court, Lucknow has been tested as COVID-19 positive, hence, District Court, Lucknow be closed for 48 hours i.e. on 11.08.2020 and 12.08.2020 for complete sanitization.

Considering the report of COVID-19 committee of District Court, Lucknow, for complete and satisfactory sanitization of the Civil Court premises, all the District Court campuses comprising of District Court campus, old High Court campus, Roshan-ud-Daula building, American Library/Family Court building are closed for 48 hours i.e. 11.08.2020 and 12.08.2020. Since 11.08.2020 is already a holiday on account of Janmashtami, District Court, Lucknow shall remain closed on 12.08.2020.

Further, Hon'ble High Court in paragraph 1 and 2 of the Letter No. 1298/LXXXVII-CPC/e-Courts/Allahabad Dated: 28 July 2020 has illustrated the guidelines for the District Courts closed under Para-14 and under Para-15 of the guidelines issued vide letter No. 1117/LXXXVII-CPC/e-Courts/Allahabad Dated: 03.06.2020.  - a) Sessions Judge,
 - b) Courts dealing with Special Jurisdiction.
 - c) Chief Judicial Magistrate.
 - d) Civil Judge (S.D.)
 - e) Civil Judge (J.D.)
- 2. During the above period, the Judicial Officers shall undertake (whereever possible), the following nature of matters,
 - Pending/Fresh Bail.
 - b) Pending and Fresh Anticipatory Bail.
 - c) Disposal of Misc. urgent Civil Applications such as injunction matters.
 - d) Disposal of urgent Civil Applications such as injunction matters.
 - e) The Judicial work/Remand in respect of under trial Prisoner.
 - f) Any other nature of matter, which the District Judge considers it appropriate.

In compliance of the aforementioned direction of the Hon'ble High Court, all the District Court premises comprising of District Court campus, old High Court campus shall remain closed on Tuesday and Wednesday i.e. 11.08.2020 and 12.08.2020 respectively. Since 11.08.2020 is already is holiday on account of Janmashtmi, on 12.08.2020, matters as described in Para-2 of Hon'ble High Court's Letter No.- 1298/LXXXVII-CPC/e-Courts/Allahabad Dated: 28 July 2020 shall be taken up by means of Videoconferencing.

Meanwhile sanitization of all the court campuses be thoroughly done under the supervision of Shri Avinash Saksena, O/C Administration/Spl. Judge P.C. Act -1, Lucknow, Shri Harendra Bahadur Singh, O/C Nazarat/Spl. Judge P.C. Act -4, Lucknow and Shri Shiva Nand, Chief Judicial Magistrate, Lucknow and report be submitted by 12.08.2020.

This order shall not be applicable with regard to Special Court (Ayodhya Prakaran), Commercial Court and Railway Claims Tribunal, Lucknow situated in old High Court premises. Similarly this order is also not applicable with regard to Family Court. They can take their own decision
