#### OFFICE OF THE DISTRICT JUDGE, LUCKNOW

#### ADMINISTRATIVE ORDER NO.: 137 /2021.

Chief Medical Officer, Lucknow vide report dated 19.04.2021 has reported that the RT-PCR test reports of officers and officials is still awaited and there are many officials whose RT-PCR report is negative but still they have symptoms of COVID-19. Owing to rapid surge of COVID-19 pandemic, District and Sessions Court, Lucknow be closed till 26.04.2021 and further has requested for complete and effective sanitization of the Court premises in regular intervals of every eight hours.

Central Bar Association, Lucknow vide letter dated 22.04.2021 has submitted that they have no objection with the opinion of C.M.O., Lucknow to close the Court till 26.04.2021 owing to the current situation of COVID-19 and the District Court, Lucknow be closed till 26.04.2021.

Lucknow Bar Association, Lucknow vide letter dated 22.04.2021 have proposed that District Court, Lucknow be closed from 23.04.2021 to 26.04.2021 and during the above period the Court premises be sanitized in regular intervals.

It has also been brought to the notice that two employees of District Court, Lucknow namely Shri Raghvendra Singh Yadav and Shri Rakesh Kumar have died due to COVID-19. Learned District Judge, Lucknow along with his family members has been tested COVID-19 positive, learned Additional District Judge, Court No. 1, Lucknow and learned Chief Judicial Magistrate, Lucknow have also been tested COVID-19 positive, several other judicial officers and officials of District Court, Lucknow are also under home isolation. Several advocates practicing in the District Court, Lucknow have also been tested positive. It has further been informed by the employees that RT-PCR report of several officers, officials and learned advocates is still awaited.

Hon'ble Allahabad High Court in para 8 of Letter No. 1941/LXXXVII-CPC/e-Courts/Allahabad/Dated: 05 April, 2021 has directed as under:-

"Where the District Administration/CMO concerned is of the opinion that the District/Outlying Court campus should be closed for a particular period and/or the District Judge/Principal Judge, Family Court, Presiding Officer, Commercial Court/Land Aqui, Rehab and Resettlement Authority/Motor Accident Claims Tribunals concerned is of the opinion that the concerned Court/Court Campus should be closed for the particular period, then such Court/ Court campus may be closed for the said period and an intimation mentioning the specific reasons may be sent to Allahabad High Court."

Owing to the present prevailing conditions in the District Court, Lucknow where some officials have died due to COVID-19 and many Officers and Officials including Learned District Judge, learned Additional District Judge, Court No. 1, Lucknow and learned Chief Judicial Magistrate, Lucknow have been tested COVID-19 positive and are under home isolation

and test reports of several employees is still awaited, it will not be appropriate to open the District Court, Lucknow, hence, considering the opinion of C.M.O., Lucknow provided vide report dated 19.04.2021, letter dated 22.04.2021 of Central Bar Association and Lucknow Bar Association, Lucknow, the District and Sessions Court, Lucknow comprising of District Court campus, old High Court building shall remain closed till 26.04.2021.

Meanwhile sanitization of all the court campus be thoroughly done under the supervision of Shri Ajay Vikram Singh, learned O/c Nazarat/Special Judge, C.B.I.(West), Lucknow and report be submitted by 26.04.2021.

Learned COVID-19 committee is called upon to furnish a report regarding prevailing and ongoing conditions of COVID-19 and spread of COVID-19 in District and Sessions Court, Lucknow by 27.04.2021

Learned I/c Chief Judicial Magistrate, Lucknow shall assign a learned Magistrate to perform remand duty and shall make necessary arrangements thereof.
