Order No. 199 /2020 (Administrative)

The District Magistrate , Ambedkar Nagar vide his letter dated 1955/JA/2020 Dated 14.10.2020 has intimated the offfice of District & Sessions Judge Ambedar Nagar that as per report of CMO Ambedkar Nagar dated 14.10.2020, Dr. Sri Babbu Sarang, District & Sessions Judge Ambedkar Nagar and Sri Dhirendra Singh , Chief Judicial Magistrate , District Court Ambedkar Nagar have been found Corona Positive today on dated 14.10.2020.

It is pertinent to mention that the District and Session Judge and the Chief Judicial Magistrate discharged their Judicial and Administrative work on 14.10.2020 and inspected the court premises also. The District & Sessions Judge along with the computer staff of the court has participated in the Video Conferencing also.

The General Secretary, Bar Association Ambedkar Nagar has also intimated vide his letter No.78/2020 Dated 15.10.2020 to the office of District & Sessions Judge that the learned Advocate Sri Sangam Lal Tiwari who is practising in the District Court has been found corona positive, his name is also figured at Serial No. 07 of the CMO report dated 14.10.2020.

Therefore, it is ordered that the District Court Ambedkar Nagar and the Outlying Court at Tanda presently running at District Headquarter are hereby remain closed on dated 15.10.2020 and 16.10.2020 in pursuance to the guidelines contained in Para No. 15 of Letter No.1117/LXXXVII-CPC/e-Courts/ Allahabad dated 03.06.2020 issued by Hon'ble High Court.

It is made clear that the Courts of, the Incharge Sessions Judge, Special Judge SC/ST Act, Special Judge EC Act, Special Judge POCSO Act, Courts dealing with case of Gangster Act & NDPS Act, Incharge Chief Judicial Magistrate ,Civil Judge(Sr. Div.), Civil Judge (Jr. Div) shall take up the judicial work through video conferencing from residential office, pertaining to the matters as contained in clause 'a' to 'f' of Para 2 of Letter No.1298/LXXXVII-CPC/e-Courts/ Allahabad dated 28.07.2020 of the Hon'ble High Court , by mode of JITSI Video - Conferencing software , as provided in the guidelines contained in the said letter.

Services of minimal Court Staff shall be taken for conducting of Court proceeding through the Video-Conferencing.

Nodal Officer Computer and System Officer to make necessary arrangement for receiving of Bail Application/ Urgent matters online till 12.00 PM, and also provide necessary assistance in respect of Court proceedings through Video- Conferencing.

It is also made clear that entry of the Lawyers and litigants in the District Court Complex is prohibited for the said period.

Computer Section, Administrative Office, Account Section and Nazarat Section shall remain open for urgent administrative work and for implementation of orders and directions received from the Hon'ble High Court.

Incharge Chief Judicial Magistrate Ambedkar Nagar, to make necessary arrangement in regards to remand of accused U/s 167 Cr.p.c as per usual holiday practice and Smt Pooja Vishwakarma, ADJ POCSO Court II shall take remand of undertrial prisoner of his court as well as all other additional Sessions courts.

The District Magistrate and Chief Medical Officer, Ambedkar Nagar, to ensure complete sanitization of the District Court premises and the court rooms.

General dates of 10.11.2020 and 11.11.2020 are hereby fixed for the cases listed on 15.10.2020 and 16.10.2020 respectively for all the courts of Ambedkar Nagar Judgeship except bail matters, cases of under trial prisoners, old cases and the cases at final stage.

Since the District Judge Ambedkar nagr is home quarantined, therefore the order is being passed by ADJ-I as Incharge District Judge
