

Feedback (07.08.2020)

In compliance of Hon'ble Court's letter no. 1117/LXXXVII-CPC/e-Courts/Allahabad dated 03.06.2020; a report was called from District Magistrate. The District Magistrate, Ayodhya has informed that the campus of District Court, Faizabad/Ayodhya is not situated under Containment Zone and also informed that two advocates of Bar Association, Faizabad and one Clerk of prosecution office have been tested 'Corona Positive' on 5.08.2020, due to which, the District Magistrate, Ayodhya has temporarily sealed the Court Campus/Bar Association Campus for two days i.e. 06.08.2020 & 07.08.2020 and prohibited the entry/exit of the said premises.


Taking in to the consideration the report of District Magistrate, all the courts of the Judgeship have been directed to be closed for aforesaid two days.

Further in compliance of the directions of Hon'ble High Court's letter no. 1298/LXXXVII-CPC/e-Courts/Allahabad dated 28.07.2020, the presiding officers of following courts of the Judgeship have been directed to take up the matters as directed in aforesaid letters of Hon'ble Court through Video Conferencing from their residential office.

Under local mechanism, a Virtual Room for advocates has been established outside the court premises in Legal Aid Clinic, in front of Tehsil Sadar, Ayodhya.
