I am directed to invite option/consent from the willing and suitable Judicial Officers of the rank of Civil Judge (Junior Division) Cadre for considering their names for appointment to the post of Law Officer (Woman), U.P. Rajya Mahila Ayog, Lucknow, on deputation basis:

The locally posted Judicial Officers will not be eligible for applying for deputation post in the same district.

The option given by the officer for the post mentioned above shall be valid for the period of one year.

If the option made by a Judicial Officer for posting on a deputation post is accepted by the Hon'ble Court, the same would not be allowed to be withdrawn ordinarily.

If the option exercised by a Judicial Officer for her posting on a deputation post is received in this Court after due date mentioned in this letter, then the same shall not be considered.
