5- Dr.(Prof.) S.K.Yacha of S.G.P.G.I. Lucknow as well as Dr. Seema Alam ,Dr. Rajeev Khanna & Dr.Vikrant Sood of ILBS advised her for **Liver Transplant in near future or alternative surgery of Partial Biliary Diversion** for better quility life of my younger daughter.

6- In addition of above treatment, she is getting Homeopathic treatment and also Ayurvedic treatment from Patanjali Yogpeeth Haridwar and from Dr. Rakesh Sharma Muzaffar Nagar.

7- Due to above rearrest disease of Liver other organ of the body involved like Heart, Spain, Eyes, Kidney, Skin etc. Due to such kind of rearrest disease she is continuosly faccing many problems like low appetite, poor physical growth, pruritus ( Itching on all over the body) at any time specially sleeping time, due to itching she got disturbed in sleeping, my wife also got disturbed in night.
