**Subject: Request for accommodating on any post at Lucknow on account of ailment of parents and change of station in mid-session.**

**Respected Sir,**

With due respect and humility at my command, I wish to bring in your honour kind notice the following facts:-

1. That the applicant has joined the judicial Service as Civil Judge (Junior Division) in the year 2009 and was given posting as Addl. Civil Judge (JD), Gonda where he remained till July,2011 and thereafter was posted at different places in the State of Uttar Pradesh.
2. That vide notification dated 19.4.2018, the applicant was given posting on the post of Addl. Chief Metropolitan Magistrate, Kanpur Nagar where he took charge on 26.4.2018.
3. That within a very short span, the applicant was sent on deputation as Chief Law Officer, U.P.Pollution Control Board, Lucknow where he took charge on 15.5.2018.
4. That here it is important to mention that the applicant opted for Lucknow posting in preference to Kanpur Nagar on account of serious ailment of his parents. The applicant's father, namely, Mr Digvijay Singh was diagnosed retinal detachment and loss vision



in the eye, for which he was put to surgery at Prakash Netra Kendra, Gomti Nagar, Lucknow, where he has to go for regular check-up. The mother of the applicant, who was the patient of Sarcodysis (lungs disease) is also under regular follow up. Copies of the Medical prescription of the parents are enclosed and marked as **Annexure-1** for kind perusal.

5. That the applicant further humbly submits that his wife Smt. Shiva Singh is the only child of her parents, who are at the fag end of their life. Therefore, her parents are also residing at the applicant's home and are being looked after by me and my wife. It may be added that mother-in law of the applicant, namely, Smt. Suniti Singh has a renal problem, for which she is under treatment at RML Insitute, Gomti Nagar, Lucknow, while the father-in-law, Sri S.P.Singh, who is a septugenarian, has developed Scoliosis in lumbar spine and has a restricted movement on account of knee replacement, which was done last year. It may be added that replacement of other knee is to be done soon. Copies of the medical prescriptions are collecitvely enclosed and marked as **Annexure-2**.
6. That it is respectfully submitted that after assuming charge in May, 2018 he got her daugther, namely, Baby Vaghisa Singh admitted in one of the prestigious college of Lucknow i.e. La Martiniere College, where she is studying in Class III.
7. That recently vide notification dated 20.8.2019, the applicant has been promoted and reverted to regular line and has been given posting as Additional District & Sessions Judge, (Fast Track Court) Faizabad.
8. That the applicant submits with respect that on account of change in station in mid-session, it would be highly difficult to get the daughter admitted in any reputed college at Faizabad resulting in adverse effect on the studies of the applicant's daughter.



9. That in view of the aforesaid difficult situation on account of serious illness of parents of the applicant and his wife, who is the sole child of her parent together with the fact that the studies of the child would be adversely affected, the applicant humbly prays for his accommodation/posting at any place in District Lucknow otherwise medical treatment of old ailing parents would be adversely affected. As mentioned above, the applicant has to look after not only his ailing parents, but of his wife too.

Wherefore, it is most respectfully prayed to kindly move the Hon'ble Court for sympathetic consideration of my representation and accommodating the applicant at any post in district Lucknow looking to the serious ailment of parents and adverse effect on the studies of the school going daughter.

For this act of kindness, the applicant shall be highly grateful.
