May kindly see the letter placed below at flag 'A', received from Sri Anil Kumar Agarwal, Special Judge, Sc/ ST (P.A.) Act, Etah regarding information about sale of his old Maruti Wagon R Car.

In his letter, Sri Agarwal has stated that he had earlier purchase second hand Maruti Wagon R car no. UP-80-X-0720 for Rs. 2,17,000/- in the year 2006 from one Dr. Rajesh Tomar of Agra through Maruti authorised dealer 'True Value' Madhusudan Motors Pvt. Ltd. Agra after takeing bank loan of Rs. 1,80,000/- and had duly informed about its purchase. The loan amount has been fully repaid. Now, he has sold the same car to Smt. Rekha Raghav, W/o Sri Gyanendra Kumar Singh, R/o Town Area Naroli, District Moradabad on 30.01.2011 for total amount of Rs. 1,00,000/- through Maruti authorised dealer 'Om Service Station', Azad Road, Chandausi. He has also submitted copies, of Certificate of the service station, delivery receipt, registration certificate of the car, and insurance policy of the car, which may kindly be seen at flag 'X', 'X-1', 'X-2' & 'X-3'. He has therefore submitted the information for kind perusal and information.

In this connection it is submitted that the officer has sold the car, which had been purchased by him earlier and had duly informed the Court (Order is at flag 'Z'). He has sold the car through 'Om Service Station', Azad Road, Chandausi, who is stated to be a Maruti authorised dealer. There seems to be nothing objectionable as per the Rule-24 (2) of U.P. Government Servant's conduct Rules, 1956, which is as follows: -

*"A Government servant who enters into any transaction concerning any movable property exceeding in value, the amount of his basic pay for one month, whether by way of purchase, sale or otherwise, shall forthwith report such transaction to the appropriate authority;  
Provided that no Government servant shall inter into any such transaction except with or through a reputed dealer or agent of standing, or with the previous sanction of the appropriate authority."*

May, if approved, the file be laid before Hon'ble Mr. Justice Imtiyaz Murtaza for his Lordship's kind perusal and information under Rule-24 (2) of U.P. Government Servant's conduct Rules, 1956?
