May kindly see the letters dated 3.5.17 (at flag 'A', 'A-1' and 'A-2')) of Dr. Avanish Kumar, Additional Civil Judge(Sr.Div.), Agra by which he has submitted his property statement for the financial years 2014-15, 2015-16 and 2016-17.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2014-15 and 2015-16 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below and the property statement for the financial year 2016-17 will be considered in the financial year 2018-19 alongwith property statement for the financial year 2017-18 as per circular letter dated 13.5.04.

(1) In the financial year 2014-15, Sri Avanish Kumar's gross income from salary is Rs.11,77,174/- from this amount, he has paid Rs.56,854/- against CPF, Rs.2600/- against GIS, Rs.1,21,295/- against Income Tax, Rs.53,122/- against LICs., Rs.60,000/- against SBI Pension plan. The balance of his Saving Bank Account(s) enhanced for Rs.2,36,555/- this year. As such, total deductions /Savings/investment is Rs.5,30,426/-. Thus a sum of Rs.6,46,748/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2014-15.

(2) In the financial year 2015-16, Sri Avanish Kumar's gross income from salary is Rs.10,76,206/- from this amount, he has paid Rs.53,089/- against CPF, Rs.3600/- against GIS, Rs.89,608/- against Income Tax, Rs.53,122/- against LICs., Rs.60,000/- against SBI Pension plan. As such, total deductions /Savings/investment is Rs.2,59,419/-. The balance of his Saving Bank Account(s) decreased for Rs.27,353/- this year. Thus a sum of Rs.8,44,140/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2015-16.

The movable and immovable property statement for the financial years 2014-15 and 2015-16 has been submitted by the officer vide his letters dated 3.5.17 (flag 'A-1' and 'A-2') which was due to be submitted in the financial year 2016-17 i.e. on or before 31.3.17. As such there is some delay in submitting the aforesaid statements from the part of the officer for which officer has regretted.

In this connection, it is submitted that Sri Avanish Kumar has already submitted his property statement upto financial year 2013-14 which was seen by Hon'ble Mr. Justice Shabihul Hasnain, the then Administrative Judge, Pratapgarh Judgeship on 7.1.15 at flag 'Z' and the said statement is at flag 'M'.

May, if approved, the statements of movable and immovable property for the financial years 2014-15 and 2015-16 of Dr. Avanish Kumar, Additional Civil Judge(Sr.Div.), Agra may kindly be laid before Hon'ble Mr. Justice Manoj Misra, Administrative Judge, Agra Judgship for His Lordship's kind perusal and orders ?
