may kindly see the application dated nil of Sri Avinash Kumar, Additional Civil Judge (Junior Division), Jaunpur duly forwarded by the District Judge, Jaunpur regarding inclusion of educational qualification in the service records, placed below at page 94.

On this aforesaid application Sri Avinash Kumar has stated that he has joined the U.P. Nyayik Sewa on 11.7.2008 in terms of G.O. ~~order~~ ^{number} of U.P. Notification No. 418/II-4-08-32(1)/2001 T.C dated 22-2-08. He has further stated ^{that} at the time of examination of 2003 (U.P. Nyayik Sewa) the degree of LL.M was with him ^{and} that ^{there-} after he obtained the degree of Ph.D (Law) in the year 2005.

On this aforesaid application, a court's letter NO. 14768/IV-3497/Admn A dated 21-11-08 was sent to the District Judge, Jaunpur with the request ~~requesting~~ to ask Sri Avinash Kumar, Additional Civil Judge (Junior Division), Jaunpur to submit the attested copies of degree of Ph.D (Law) ^{and degree of LL.M} to this court.

In compliance of aforesaid court's letter dated 21-11-08, Sri Avinash Kumar has submitted the attested copies of degree of Ph.D (Law) and degree of LL.M through his application dated nil, to this court for necessary action in the matter.

Now Sri Avinash Kumar has requested to this court ^{that} the aforesaid educational qualification may kindly be included in his service records.

In this connection it may be submitted that from a perusal of form of U.P Nyayik Sewa

(tagged 'Y') of Sri Avinash Kumar, it is evident that the qualification of LL.M of Sri Avinash Kumar is shown by him. The degree of LL.M is also available in his service records. The qualification of Ph.D (Law) of Sri Avinash Kumar is not shown in the form of U.P Nyayik Sewa. The degree of Ph.D (Law) is awarded to him on 02-4-2007.

In this connection it may also be submitted that appointing authority of judicial officers of U.P Nyayik Sewa is Government of U.P. Lucknow and he ~~has~~ got the appointment in U.P. Nyayik Sewa through Notification NO 418/II-4-68-32(1)/2001 T.C dated 22-2-2008 (tagged 'X'). Therefore, it seems proper that the photocopy of degree of Ph.D (Law) (tagged 'C') of Sri Avinash Kumar, Additional Civil Judge (Junior Division), Jaunpur may be sent to the Government of U.P for obtaining necessary orders as the appointing authority of the judicial officers is the Government of U.P.

As approved by Honble Mr Justice Rakesh Sharma, Administrative Judge, Jaunpur, the photocopy of degree of Ph.D (Law), copy of application dated 14 of Sri Avinash Kumar, Additional Civil Judge (Junior Division), Jaunpur regarding inclusion of qualification and photocopy of form of U.P. Nyayik Sewa of Sri Avinash Kumar may be sent to the Deputy Secretary, Administrative Section-4, Government of U.P. Lucknow for obtaining necessary orders of the Government.
