On this aforesaid application Sri Avanish Kumar has stated that he has joined the U.P. Naik service on 11.7.2002 in terms of G.O.M.R. 12001 T.C dated 22-2-08. He has further stated that at the time of examination of 2003 (U.P. Naik service) the degree of LL.M was with him and thereafter he obtained the degree of Ph.D (Law) in the year 2005.

On this aforesaid application, a cover letter NO. 14768/IV - 3497 / Admin A dated 21-11-08 was sent to the District Judge, Jaunpur with the request ~~requesting~~ to ask Sri Avanish Kumar, Additional Civil Judge (Junior Division), Jaunpur to submit the attested copy of degree of Ph.D and degree of LL.M (Law) to this cover.

In compliance of aforesaid cover's letter dated 21-11-08, Sri Avanish Kumar has submitted the attested copy of degree of Ph.D (Law) and degree of LL.M through this application dated 11/11/08, to this cover for necessary action in the matter.

Now Sri Avanish Kumar has requested that to this cover, the aforesaid educational qualification may kindly be included in the service records.

In this connection it may be submitted that from a perusal of form of U.P. Naik service

(tagged 'Y') of Sri Avanish Kumar, it is evident that the qualification of LL.M of Sri Avanish Kumar is shown by him. The degree of LL.M is also available in his service records. The qualification of Ph.D (Law) of Sri Avanish Kumar is not shown in the form of U.P. Nyayik Sewa. The degree of Ph.D (Law) is awarded to him on 02-4-2007.

In this connection it may also be submitted that appointing authority of judicial officers of U.P. Nyayik Sewa is Government of U.P. Lucknow and he ~~has~~ got the appointment in U.P. Nyayik Sewa through Notification NO 418/I-4-68-32(1)/2001 T.C dated 22.2.2008 (tagged 'X'). Therefore, it seems proper that the photocopy of degree of Ph.D (Law) (tagged 'C') of Sri Avanish Kumar, Additional Civil Judge (Junior Division), Jaunpur may be sent to the Government of U.P. for obtaining necessary orders as the appointing authority of the judicial officers is the Government of U.P.
