May kindly see the letter dated 17.1.18 (flag 'A') received from Sri Ateeq Uddin, Additional Chief Judicial Magistrate, Farrukhabad regarding submission of statements of movable and immovable properties acquired/held by him or by any member of his family for at the date of joining the Judicial Service, and financial years 2009-10 (23.3.2009 to 31.3.2010), 2010-11, 2011-12, 2012-13, 2014-15 and 2015-16 in prescribed proforma to this Court for kind perusal and information as required by the Court's circular letter No.16/IV-h-16/Admin.(A), dated 13.5.2004.

Earlier officer has submitted his property statement at the time of joining the Judicial Service /financial year 2009-10 vide his letter dated 8.10.10(flag 'B') which was not according to the Court Circular letter dated 13.5.04, hence Court's letters dated 15.3.2011(flag 'C') and 26.9.2015(flag 'D') has been sent to the officer to sent his property statements for at the time of entering into Judicial service and for the financial years 2009-10, 2010-11, 2011-12 and 2012-13 after mentioning the details of deductions of Salary alongwith reasons for delay.

In reply of aforesaid Court's letters, Officer has submitted his property statements for at the date of joining the Service, 2009-10, 2010-11, 2011-12, 2012-13, 2014-15 and 2015-16 vide his letter dated 17.1.2018(flag 'A').

In this connection, it is submitted that as per statement of movable and immovable property at the date of joining the Service and financial years 2009-10, 2010-11, 2011-12, 2012-13, 2014-15 and 2015-16 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by her are given below:-

- (1) At the date of joining the Judicial Service, Sri Atiq Uddin's has ornaments (ancestral) of gold weight 70 gms., Agriculture land (ancestral) 4.9000 acres, two houses (ancestral) located at ward no. 15 town alapur Distt. Budaun total residential area 6125 Sq. ft.
- (2) In the financial year, 2009-10, Sri Atiq Uddin's gross Salary salary is Rs.2,44,554/- from this amount he has paid Rs.1320/- against GIS, Rs.7555/- against Income Tax. The balance of his Saving Bank Account(s) enhanced for Rs.11,800/- this financial year. As such, total deductions /Savings/investment is Rs.20,695/-. Thus a sum of Rs.2,23,879/- was therefore available with him to meet out the household expenditure of his family consisting of two members (including his mother) in the financial year 2009-10.
- (3) In the financial year, 2010-11, Sri Atiq Uddin's gross Salary salary is Rs.5,34,446/- from this amount he has paid Rs.1440/- against GIS, Rs.37,276/- against Income Tax. The balance of his Saving Bank Account(s) enhanced for Rs.1,49,924/- this financial year. As such, total deductions /Savings/investment is Rs.1,88,640/-. Thus a sum of Rs.3,45,806/- was therefore available with him to meet out the household expenditure of his family consisting of two members (including his mother) in the financial year 2010-11.
- (4) In the financial year, 2011-12, Sri Atiq Uddin's gross Salary salary is

Rs.6,42,183/- from this amount he has paid Rs.1440/- against GIS, Rs.49,137/- against Income Tax and Rs.68,820/- repayed against loan. As such, total deductions /Savings/investment is Rs.1,19,397/-. The balance of his Saving Bank Account(s) decreased for Rs.1,08,587/- this financial year. Thus a sum of Rs.6,31,373/- was therefore available with him to meet out the household expenditure of his family consisting of two members (including his mother) in the financial year 2011-12.

(5) In the financial year, 2012-13, Sri Atiq Uddin's gross Salary salary is Rs.6,75,666/- from this amount he has paid Rs.2400/- against GIS, Rs.64030/- against CPF, Rs.441,32/- against Income Tax, Rs.72,000/- repayed against loan and Rs.12,000/- against NSC. As such, total deductions /Savings/investment is Rs.1,94,562/-. The balance of his Saving Bank Account(s) decreased for Rs.33,083/- this financial year. Thus a sum of Rs.5,14,187/- was therefore available with him to meet out the household expenditure of his family consisting of three members (including his mother) in the financial year 2012-13.

(6) In the financial year, 2013-14, Sri Atiq Uddin's gross Salary salary is Rs.7,05,372/- from this amount he has paid Rs.2400/- against GIS, Rs.67,060/- against CPF, Rs.49,750/- against Income Tax, Rs.72,000/- repayed against loan and Rs.12,000/- against NSC. As such, total deductions /Savings/investment is Rs.2,03,210/-. The balance of his Saving Bank Account(s) decreased for Rs.5771/- this financial year. Thus a sum of Rs.5,07,933/- was therefore available with him to meet out the household expenditure of his family consisting of three members (including his mother) in the financial years 2013-14.

(7) In the financial year, 2014-15, Sri Atiq Uddin's gross Salary salary is Rs.12,66,007/- from this amount he has paid Rs.2400/- against GIS, Rs.1,07,120/- against CPF, Rs.1,20,314/- against Income Tax, Rs.72,000/- repayed against loan and Rs.18,000/- against NSC. The balance of his Saving Bank Account(s) enhanced for Rs.1,48,739/- this financial year. As such, total deductions /Savings/investment is Rs.4,68,573/-. Thus a sum of Rs.7,97,434/- was therefore available with him to meet out the household expenditure of his family consisting of four members (including his mother) in the financial years 2014-15.

And as per two years block policy, the property statement for the financial year 2015-16 will be taken up for consideration alongwith property statement for the financial year 2016-17, which will be submitted by the officer in near future, be due in the financial year 2017-18.

This is the first statement submitted by the officer. The movable and immovable property statement at the date of joining the Service earlier submitted by the officer vide his letter dated 8.10.10(flag 'B') and property statements for the financial years 2009-10, 2010-11, 2011-12, 2012-13, 2013-14, 2014-15 has been submitted by the officer vide his letter dated 17.1.18 (flag 'A').
