May kindly see the letter dated 22.08.2013 of Sri Anil Kumar Singh II, Judicial Magistrate, Jyotiba Phule Nagar duly forwarded by the District Judge, Jyotiba Phule Nagar, to this Court regarding inclusion of degree of Doctor of Philosophy (Ph.D.) in Law and add Doctor before his name and remove "II" after his name in his service records placed below at Flag 'A'.

In his aforesaid letter Sri Anil Kumar Singh II, Judicial Magistrate, Jyotiba Phule Nagar has submitted attested copy of LL.M. degree (at Flag 'B') and stated therein that he has submitted thesis of Ph.D. on the topic of "Arbitration Law and Practices in India: Recent Developments and Impact of Globalisation" in Aligarh Muslim University, Aligarh with the permission of Hon'ble High Court. He has also stated that he gave Viva-voce on 22.06.2013 and honoured with Ph.D. from Aligarh Muslim University, Aligarh on 20.08.2013. He has requested the Court for inclusion of degree of Doctor of Philosophy (Ph.D.), add "Doctor" before his name and remove "II" after his name in his service records.

In this connection it may be submitted that Sri Anil Kumar Singh II has joined U.P. Nyayik Sewa on 17.04.2009 and he has completed degree of Doctor of Philosophy (Ph.D.) from Aligarh Muslim University, Aligarh with the permission of Hon'ble High Court vide order of Hon'ble the Chief Justice dated 26.04.2012 (at Flag 'C') after joining of U.P. Nyayik Sewa.

In this connection, it is further submitted that Appointing authority of Judicial Officers is Government of U.P. The degree of Doctor of Philosophy (Ph.D.) may be included, add "Doctor" before the name and remove "II" after the name in the service records of Sri Anil Kumar Singh II with the permission of Government of U.P. as the appointing authority of Judicial Officers is Government of U.P. Therefore, it seems proper the application of Sri Anil Kumar Singh II, Judicial Magistrate, Jyotiba Phule Nagar regarding inclusion of degree of Doctor of Philosophy (Ph.D.), add "Doctor" before the name and "II" after the name in his service records may be sent to the Government for obtaining orders.
