May kindly see the letter dt. 08-06-2015 (flagged at 'A') of Dr. Anil Kumar Singh-II, Civil Judge(J.D.), Allahabad duly forwarded by the District Judge, Allahabad for issuing necessary directions regarding already granted three advance increments to him.

In this connection it is relevant to mention here that three advance increments was granted to Dr. Anil Kumar Singh-II, the then Judicial Magistrate, Amroha and presently posted as Civil Judge(J.D.), Allahabad by this Court and in compliance of which a Court's letter No. 14345 dt. 09-10-2013 (flagged at 'B') was issued to District Judge, Amroha for allowing three advance increments with dearness allowance to Sri Singh-II w.e.f initial date of his joining in judicial service.

In aforesaid letter Sri Anil Kumar Singh-II stated that in pursuance of this Court's order dt. 09-10-2013, the District Judge, Amroha in the capacity of Drawing & Disbursing Officer arrear pay-bill arised after giving benefit of three advance increment, was sent to Senior Treasury Officer, Amroha for payment which was objected by S.T.O giving the reason that arrear be drawn after adjusting three advance increments in the coming year. Consequently against this objection, a letter was written to S.T.O, Amroha by the District Judge, Amroha(As D.D.O) stating that it has not been mentioned in any line or at any stage of aforementioned order of High Court that three advance increments shall be adjusted against regular annual increments. But S.T.O., Amroha was not inclined to delete his earlier objection. In view of said objection, the District Judge, Amroha as DDO again sent a letter on 11-07-2014 to Additional Director Treasury, Allahabad on this matter and reply of the same is still awaited. When the matter was no solved by the competent authority at any stage, then he requested to this Court to issue necessary appropriate directions for the solution of the matter.

In this regard it is pertinent to mention here that in pursuance of G.O.s and guidelines approved by Hon'ble the Chief Justice, three advance increments are being granted to the Judicial Officers of U.P. Nyayik Sewa and U.P. Higher Judicial Service(Direct Recruits) who have been selected on or after 21<sup>th</sup> March, 2002 having two years Degree of LL.M from a recognized University. These increments, if so granted, are additional in nature and be granted to the officer in addition to his/her regular annual increments with effect from his/her initial date of joining in judicial service. These additional increments can not be and shall not be adjusted against subsequent annual increments. These additional increments have been recommended by the First National Judicial Pay Commission famously known as Setty Commission by acknowledging the fact that Post-Graduation in Law is a difficult course and it is better to reward appropriately.

In view of above facts and circumstances, may, if deemed fit and proper, the file be placed before the Ld. Senior Registrar, for kind perusal and order to the effect that Treasury Officer, Allahabad be requested to allow three advance increments to Sri Anil Kumar Singh-II, the then Judicial Magistrate, Amroha and presently posted as Civil Judge(J.D.), Allahabad over and above his annual increments with effect from his initial date of joining in service without further delay and a copy to this effect be sent to the Additional Director Treasury, Allahabad for issuing necessary directions.
