May kindly see the letter, placed below at flag 'Z', received from Sri Anil Kumar Singh, the then Additional Civil Judge (Junior Division), Etawah presently posted as Judicial Magistrate, J.P. Nagar by which he has submitted supplementary/required papers i.e. copy of passbook of his S.B. A/c no. 30167640313, in connection with purchase of new Hyundai i-10 car.

In this connection, it is submitted that the officer through his earlier letters in the year 2010 has submitted information about purchase of a new Hyundai i-10 car for Rs. 3,75,298/-, after taking bank loan of Rs. 3,00,000/- from S.B.I. and by paying Rs. 75,298/- from his S.B. A/c. The matter was submitted before Hon'ble Judge, vide detailed office note dated 03.09.2010 (flagged '2') and a supplementary note dated 16.12.2011 (flagged '2A') was lastly submitted in the matter, upon which His Lordship has been pleased to order on 23.02.2012 to **obtain copy of bank passbook** The copy of passbook has been asked through Court's letter dated 02.03.2012 (flagged '2B').

In reply of the Court's letter dated 02.03.2012 Sri ^{S. Singh} Verma, vide his letter dated 22.03.2012 at flag '2C' has submitted attested copy of passbook of his said S.B. A/c but it was not appropriate as particular entries of payment were missing. Thus, another Court's letter dated 02.06.2012 (flagged '2D') was sent to the officer asking copy of passbook.

Now, the officer has sent a reply of the above mentioned letter dated 02.06.2012, vide his letter dated 24.07.2012 (flagged 'Z') in which he has stated that he has sent attested copy of pass book of his A/c No. 30167640313, S.B.I., AMU, Aligarh in which entries are made only for E.M.I. He wants to be pardoned for typical mistake occurred in the letter of information of purchase of vehicle no. UP 81 AC 5673 that he has done advance payment from the above mentioned account. Actually he has done payment by borrowing money from his parents for advance payment. Later on he got sanction Personal Loan with A/c No. 27240600001027, Bank of Baroda, Etawah for payment of this borrowed money. This Personal Loan was sanctioned to him from Salary A/c no. 27240100020916, Bank of Baroda, Etawah. He repayed borrowed money to his parents in several installments after withdrawing from his Salary A/c no. 27240100020916, Bank of Baroda, Etawah. He is enclosing the Bank Statement of Personal Loan in the support of his statement. He has, therefore requested to pardon him for that typical mistake and take notice of his statement of advance payment arranged from his parents and repayed to them after sanction of Personal loan from his S.B. A/c No. 27240100020916, Bank of Baroda, Etawah.
