May kindly see the letter, placed below at flags '33' received from Sri Anil Kumar Singh, Judicial Magistrate, J.P. Nagar by which he has submitted supplementary details/ papers in connection with information about purchase of a new Hyundai i-10 car in compliance of Court's order.

In this connection, it is submitted that the officer through his earlier letters in the year 2010 has submitted information about purchase of a new Hyundai i-10 car for Rs. 3,75,298/-, after taking bank loan of Rs. 3,00,000/- from S.B.I. and by paying Rs. 75,298/- from his S.B. A/c. The matter was submitted before Hon'ble Mr. Justice Sanjay Misra, vide detailed office note dated 03.09.2010 (flagged '2') and a supplementary note dated 16.12.2011 (flagged '2A') was lastly submitted in the matter, upon which His Lordship has been pleased to order on 23.02.2012 to **obtain copy of bank passbook**. The copy of passbook has been asked through Court's letter dated 02.03.2012 (flagged '2B').

In reply of Court's letter dtd. 02.03.2012, Sri Singh vide his letters dtd. 22.03.2012 (flagged '2C') and 24.07.2012 (flagged 'Z') had submitted attested copy of passbook of his said S.B. A/c and had stated that actually he had done payment by borrowing money from his parents for advance payment. Later on he got sanction Personal Loan with A/c no. 27240600001027, Bank of Baroda, Etawah for payment of his borrowed money. This Personal Loan was sanctioned to him from Salary A/c no. 27240100020916, Bank of Baroda, Etawah. He repayed borrowed money to his parents in several installments after withdrawing from his Salary A/c no. 27240100020916, Bank of Baroda, Etawah. He is enclosing the Bank Statement of Personal Loan in the support of his statement.

Upon receipt of his above mentioned letters, the matter was again submitted before His Lordship through office note dated 22.08.2012 (flagged '3A'), and His Lordship had been pleased to pass an order dated 07.09.2012 that **The officer may be asked to specify the amount of loan taken by him from his father and whether it was free of interest and if the amount was more than his two month's basic pay, has he taken permission for the same**. The order was communicated through letter dated 14.09.2012 (flagged '3B')

In reply of the Court's letter dated 14.09.2012 (flagged '3B'), Sri Anil Kumar Singh, vide his letter dated 30.11.2012 at flag '33' has submitted that he has taken an amount of Rs. 50,000/- from his father. This amount was free from interest and it was less than his two month's basic pay. He had earlier enclosed statement of his bank A/c no. 2724010000020916, Bank of Baroda, Etawah from

where he withdrew the amount for re-payment to his father.

In this connection it is further submitted that now as the officer has informed that the amount taken from his father as interest free loan is less than of his two month's basic pay, there appears to be nothing objectionable and was also not required to take prior permission under the provision of Rule 22 (2) of U.P. Govt. Servant's Rule 1956 mentioned as below:

No Government servant shall, save in the ordinary course of business with a bank, Co-operative Society or a firm, or otherwise, place himself under pecuniary obligation to any person within the local limits of his authority, nor shall he permit any member of his family, except with the previous sanction of the appropriate authority, to enter into any such transactions:

Provided that a Government servant may accept a purely temporary loan not exceeding in value the amount of his two months' basic pay free of interest, from a personal friend or relative or operate a credit account with a bona fide tradesman.

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Sanjay Misra for His Lordship's kind perusal & further order in the matter of information about purchase of a new Hyundai i-10 car by the officer now?
