May Kindly see the Fax letter, placed below at flag 'A', received from Sri Pranjal Aneja, Civil Judge (Junior Division), Budaun by which he has requested for grant of permission to appear in viva-voce of Delhi Judicial service Examination, 2010.

In his letter, Sri Pranjal Aneja has stated that he received a letter from Hon'ble High Court of Delhi to appear in viva-voce to be held on 16-12-2010. He has further stated that for preliminary and mains Examination he had previously sought for and was granted permission by the Hon'ble High Court of Judicature at Allahabad on 18-08-2010. He has, therefore, requested the Court to grant him permission to appear in viva-voce of Delhi Judicial Service Examination, 2010 to be held on 16-12-2010.

In this connection, it is submitted that the officer has joined the U.P.Nyayik Sewa in April 2009. Earlier he had been granted permission to appear in the Delhi Judicial Service (pre. & Mains) Examination, 2010. as requested, vide Court's Order, 12-08-2010 at flag 'O' communicated vide court's letter dated 18-08-2010. However, he has again requested to grant him permission to appear in viva-voce of Delhi Judicial service Examination, 2010. Permission to appear in such type of viva voce may be accorded but subject to the following conditions: -

- (1) Government work should not suffer in any way.
- (2) No preferential treatment will be given in the matter of leave, postings and transfer.
- (9) The permission can be withdrawn without notice if; it is found at any time that the government servant neglect his normal work or that public work suffers in any way.

Sahi, Administrative Judge, Budaun Judgeship, permission be accorded to Sri Pranjal Aneja, Civil Judge (Junior Division), Budaun to appear in viva-voce of Delhi Judicial service Examination, 2010 to be held on 16-12-2010, as requested, subject to the conditions mentioned above?
