May kindly see the letter, placed below at flag 'A', & 'A-1' received from Sri Pranjal Aneja, Civil Judge (Junior Division), Budaun for grant of permission to appear in the Delhi Judicial Service Examination, 2010 mains exam.

Sri Pranjal Aneja in his earlier letter dated 14-12-2009 (flag 'B') had stated that he wants to apply Delhi Judicial Service Examination, 2010. He had therefore, requested the Court for permission for applying in Delhi Judicial Service Examination, 2010. As at the time of receipt of his said letter the last date for apply for pre. Examination appears to be passed over, as discussed with Registrar. (B) mention of which is on the note dated 11-01-2010 (flagged 'C')) he was asked vide Court's letter dated 09-02-2010 to intimate the last date of submission of application form of Delhi Judicial Service Examination, 2010, proposed date of preliminary/ Mains examination and as to whether he has already applied for the examination and, if yes, to furnish a copy of application form. In the reply of aforesaid Court's letter, Sri Aneja sent a letter dated 11-03-2010 (flagged 'A') in which he has stated that the last date or submission of application form of Delhi Judicial Service Examination, 2010 was 21-12-2009 for which he had applied and appear in above exam from the Hon'ble Court on 16-12-2009, and in anticipation of grant of permission he applied for the exam on the same date i.e. 16-12-2009 and appeared in the preliminary exam held on 14-02-2010. He had also enclosed an application form (flagged 'D'). He had further stated that the proposed dated for the mains exam is 6th & 7th June, 2010. He has therefore requested the Court to grant him permission to appear in the Delhi Judicial Service Examination, 2010, mains exam also. Thereafter, he was asked to intimate about the result of Delhi Judicial Service (Preliminary) Examination, 2010, as to whether he has qualified for the mains examination vide Court's letter dated 17-05-2010 (flagged 'E')

Now, in reply Court's letter dated 17-05-2010, Sri Aneja has sent a letter dated 15-07-2010 (flagged 'A-1'), in which he has stated that he passed the Delhi Judicial Service (Preliminary) Examination, 2010, and in anticipation of permission sought vide letter dated 11-03-2010 to appear in the mains exam, he appeared in the mains exam held on 6th & 7th June. 2010.

In this connection, it is submitted that the officer has joined the U.P. Nyayik Sewa in April 2009. It is pertinent to mentioned here that on 14-02-2010 Delhi Judicial Service (Preliminary) Examination, 2010 had already conducted and the Officer has appeared in the preliminary ^{Exam} in anticipation of Court's permission. He has also passed the preliminary exam and also appeared in the main exam in anticipation of Court's permission which was held on 6th & 7th June-2010. As per facts & circumstances, it would be proper that he may be granted ex-post facto permission to appear in Delhi Judicial Service (Pre. & Mains) Examination, 2010, as he has already appeared in the same after applying for permission & in anticipation of Court's permission.

May, therefore, if approved by Hon'ble Mr. Justice A.P. Sahi, Administrative Judge, Budaun Judgeship, ex-post facto permission be accorded to Sri Pranjal Aneja, Civil Judge (Junior Division), Budaun to appear in the Delhi Judicial Service (Pre. & Mains) Examination, 2010?
