

**Joint Registrar (M)**

May kindly see letters dated 07.03.2011, placed below at **Flag 'A' & 'B'** respectively received from Sri Pranjal Aneja, Additional Civil Judge (Jr. Div.)/Judicial Magistrate, Sahaswan, Budaun addressed to the Registrar General of this Court and His Excellency, the Hon'ble Governor of Uttar Pradesh, (Appointing Authority), duly forwarded by the District Judge, Budaun regarding resignation from the U.P. Judicial Service for joining Delhi Judicial Service.

In his aforesaid letters Pranjal Aneja has submitted the following facts:-

- (1) That he belong to the 2006 batch of Civil Judges (Junior Division) and had taken over the charge of his aforesaid post in the District Court Budaun on 20.04.2009 and he is presently posted at Sahaswan (Outlying Court) in District Budaun since 13.01.2011.
- (2) That under prior permission from the Hon'ble Court, he had appeared in the competitive examination of Delhi Judicial Service Examination, 2010.
- (3) That vide letter No. 670/Gaz.VI.e.2(a)/2011 dated 21.02.2011 issued by the Hon'ble High Court of Delhi on the basis of Notification No. F.6(26)/09-Judl./Suptlaw/175-180 dated 17.02.2011 issued by the Government of NCT of Delhi (photocopies are placed at Flags 'C' & 'D'). He has been asked to take over the charge of ~~one~~ post as a member of the Delhi Judicial Service .
- (4) That his native place is Muzaffarnagar in U.P. which is near to Delhi. His old and ailing parents reside there and ~~he~~ being their only son, <sup>he</sup> would be in a better position to look after them in their old age if he joins the Delhi Judicial Service.
- (5) That for the above stated reasons, he wants to resign the U.P. Judicial Service voluntarily and unconditionally and join the Delhi Judicial Service at the earliest as has been required by the Hon'ble High Court of Delhi.

(6) That he is submitting his resignation letter (placed at Flag 'B') addressed to His Excellency, the Governor of Uttar Pradesh, as required under rule 4 of the U.P. Government Servants Resignation Rules, 2000.

(7) That in view of the directions of the Hon'ble Delhi High Court vide aforesaid letter to join the Delhi Judicial Service at the earliest, he most humbly requested that the necessity of giving three months prior notice to resign as required under rule 4 of the U.P. Government Servants Resignation Rules, 2000 be kindly relaxed and his resignation may kindly be accepted at the earliest.

(8) That he hereby furnish the information to the Hon'ble Court to resign the U.P. Judicial Service as required under rule 4 of the U.P. Government Servants Resignation Rules, 2000.

In this connection it is submitted that as per report of office of Spl. Officer (Vig.), O.S.D. (Enquiry) and Confidential Section **at Flag 'X', 'Y' & 'Z'**, respectively, no departmental / vigilance enquiry is pending against Sri Pranjal Aneja, Additional Civil Judge (Jr. Div.)/Judicial Magistrate, Sahaswan, Budaun.

It is also to mention here that under the provision of Rule - 4 of U.P. Government Servant Resignation rules, 2000, (1) a Government Servant may resign from his service by giving three month's notice in writing (2) The notice of resignation shall be - (i) voluntary and unconditional, (ii) addressed to the appointing authority under intimation to the authority under whom the said Government servant is working at the time of tendering resignation: Provided that it shall be open to the appointing authority to allow a government servant to resign without any notice or by a shorter notice.

It is pertinent to mention here that the appointing authority of judicial officers is the Hon'ble Governor / Government of U.P. and as such, under the circumstance of the case, it seems to be proper that the letters dated 07.03.2011, received from Sri Pranjal Aneja, Additional Civil Judge (Jr. Div.)/Judicial Magistrate, Sahaswan, Budaun may be sent to the Government of U.P. for taking necessary action after

treating it as letter of resignation from U.P. Judicial Service after waiving the proviso of three month's notice.

May, therefore, if approved by Hon'ble the Chief Justice, the letters dated 07.03.2011, received from Sri Pranjal Aneja, Additional Civil Judge (Jr. Div.)/Judicial Magistrate, Sahaswan, Budaun may be sent to the Special Secretary, Appointment Section-4, Government of U.P., Lucknow for treating it as letter of resignation having waived out the three month's notice as required?

If further approved by His Lordship the Government may be informed that no Departmental / Vigilance enquiry is pending against Sri Pranjal Aneja, Additional Civil Judge (Jr. Div.)/Judicial Magistrate, Sahaswan, Budaun?
