May kindly see the application/ letter at flag 'A', received from Sri Ajay Vikram Singh, Additional Civil Judge (Junior Division), Gonda, by which he has requested the Court for grant of permission/ issuance of 'No Objection Certificate' for renewal of Passport.

In his letter, Sri Singh has stated that his passport bearing no. A-9527647, which was issued on 26.03.2001 before his joining the judicial service, has now been expired on 25.03.2011. He has also submitted the required details/ declaration as follows:-

1. There is no possibility of arising embarrassing position before the Govt. of India or the Govt. of U.P. due to his visit to a foreign country.
2. No such type of request was ever refused to him.
3. He has not visited any foreign country till now earlier.

He has also submitted details of his dependents, his photographs & earlier issued passport (flag 'B') and has requested for issuance of 'No-Objection Certificate' for renewal/ obtaining Passport.

In this connection, it is submitted that 'No-objection Certificate' for obtaining a Passport may be issued to the officers in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 (flagged 'C'). The officer has joined the judicial service on 21.04.2009 and he had obtained passport earlier in the year 2001. Now, as his passport has been expired and he wants to get it renewed, 'No Objection Certificate' for the purpose may be granted as per the provisions of the aforementioned G.O. dated 14.06.1999. It is further submitted that as per reports placed below, no departmental/ vigilance enquiry is pending against Sri Singh. Presently, as per orders of the Court, 'No-objection Certificates' are being issued to judicial officers for obtaining Passport.

May, therefore, if approved by Hon'ble Mr. Justice Shabihul Hasnain, Administrative Judge, Gonda, Judgeship, the 'No Objection Certificate' at flag 'D' be issued, in favour of Sri Ajay Vikram Singh, Additional Civil Judge (Junior Division), Gonda, for renewal/ obtaining Passport with the direction that he should take prior permission of the Court before proceeding abroad?
