May kindly see the letter dated 25.6.13 (flagged 'A' ) by which Sri. Ajai Vikram Singh, Civil Judge(Jr.Div.), Unnao has submitted his consolidated Property statement for the two financial years 2011-12 and 2012-13.

In this connection it is submitted that from perusal of the Property statement for the financial years 2011-12 and 2012-13, Sri Singh total income from salary is. Rs.13,70,366/- from this amount he has subscribed/deposited Rs.77,880/- in NPS, Rs.4800/- in GIS, Rs.1,10,094/- is LIC premium, Rs.200,000/- in PPF, Rs.20,000/- in Bond and Rs.95,000/- in others i.e. Agriculture income and interest. The total deduction and investment is Rs.5,07,774/- . Thus a sum of Rs.8,62,592/- was therefore available to him to meet out his family expenditure in two financial years.

The movable and immovable property statement for the financial years 2011-12 and 2012-13 has been submitted by the officer vide his letter dated 25.6.13(flagged 'A') which was due to be submitted in third financial years 2013-14 i.e on or before 31.3.14 . As such there is no delay in submitting the aforesaid property statement from the part of officer.

In this connection it is submitted that Officer has already submitted her property statement upto financial year 2010-11 which has already been seen by Hon'ble Mr. Justice Shabihul Hasnain, the then Administrative Judge, Gonda Judgship on 19.3.12 at flag 'Z' and the said statement at flag 'M'.
