May kindly see the letter dated 24.9.15 (at flag 'A') of Sri Ajai Vikram Singh, Judicial Magistrate, Barabanki by which he has submitted the payment of Income Tax of the financial years 2014-15 in connection with submission of property statements for the financial years 2013-14 and 2014-15.

Earlier Sri Singh has submitted the consolidated property statements for the financial years 2013-14 and 2014-15 vide his letter dated 27.6.15 & 19.8.2015 (flag 'X' and 'B'), in which he has not mentioned the payment of Income Tax of the financial years 2014-15, hence Court letters dated 6.8.15 & 18.9.2015 (flag 'C' and 'C-1') has been sent to the officer in this regard.

In reply of aforesaid Court letter, Officer has submitted the payment of Income Tax of the financial years 2014-15 vide his letter dated 19.8.15 & 24.9.2015(flag 'B' and 'A').

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2013-14 and 2014-15 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

(1) In the consolidated statement of movable and immovable property for the financial years 2013-14 and 2014-15, Sri Singh total Income from Salary is Rs.19,86,672/- from this amount, he has paid Rs.1,44,824/- against NPS, Rs.4800/- GIS, Rs.1,13,126/- against LIC, Rs.2,50,000/- against PPF, Rs.2,000/- against Sukanya Dhan Yagna. The balance of his Saving Bank Account(s) enhanced for Rs.2,43,500 this financial year. As such, total deductions /Savings/investment is Rs.7,58,250/-. Thus a sum of Rs.12,28,422/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial years 2013-14 and 2014-15.

It is pertinent to mention here that the income of the wife of the officer is Rs.2.50 (as mentioned in the aforesaid consolidated property statements.

The movable and immovable property statement for the financial year 2013-14 and 2014-15 has been submitted by the officer vide his letter dated 19.8.15 ('B') which was due to be submitted in the financial year 2015-16 i.e. on or before 31.3.16. As such there is no delay in submitting the property statement from the part of the officer.

In this connection, it is submitted that Sri Singh has already submitted the property statement upto financial year 2012-13 which was seen by Hon'ble Mr. Justice Dinesh Gupta, the then Administrative Judge, Unnao Judgeship 3.9.13 at flag 'Z' on and the said statement is at flag 'M'.
