May kindly see the letter, placed below at **flag 'A'**, received from Sri Ajay Vikram Singh, Additional Chief Judicial Magistrate, Barabanki regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial years 2015-16 and 2016-17 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2015-16 and 2016-17 of the officer concerned, details of income, deductions, savings investment and expenditure made by him are given below.

(1) In the financial year 2015-16 & 2016-17, income from salary is Rs.21,60,730/-, income from allowances is Rs.82,466/- and income from interest & agriculture is Rs.48,000/-. Thus, the total amount is Rs.22,91,196/- and from this amount, Rs.8,200/- is deducted against GIS, Rs.2,04,306/- against NPS, Rs.9,200/- against NSC, Rs.1,15,230/- against premium of LIC policies, Rs.49,321/- against mediclaim policy, Rs.3,00,000/- against Sukanya Yojna, Rs.1,92,257/- against Income Tax and Rs.2,58,200/- deposited in his PPF account. As such, total deductions/ repayment/ savings/ investment is Rs.11,36,714/-. The balance of his savings bank account(s) reduced for Rs.1,65,584/- this financial year from previous year's balance. Thus, a sum of Rs.13,20,066/- was therefore available with him to meet out the household expenditure of his family consisting of three members in whole of the financial years 2015-16 & 2016-17.

It is pertinent to mention here that his wife's income is Rs.2,50,000/- (approx.) from Law profession.

In this connection it is submitted that Sri Ajay Vikram Singh has already submitted his property statement upto the financial year 2014-15 (statement is at **flag 'M'**) which had already been seen by Hon'ble Mr. Justice D.K.Arora, the then Administrative Judge, Barabanki at **flag 'Z'**.

It is further submitted that as per policy/Court's Circular Letter, the officer

...as to submit his property statement for the financial year 2015-16 & 2016-17 in its next financial year i.e., in 2017-18 up to March 2018.
