Please take notice of the letter mentioned above. In this respect I have to submit that I opened a PPF Account No. 5312 with the Head Post Office Gorakhpur on 09-07-2009 depositing Rs.1000.00 after entering the present service. When post offices started CBS services, the new Account No. allotted to me is 0063903089. I could not deposit any money during years 2009-10,2010-11,2011-12,2012-13 and 2013-14. I deposited Rs.42000.00 only on 30.03.2015.


