May kindly see the letter, placed below at flag '1', received from Sri Shrikrishna Chandra Singh, Deputy Director, JTRI, UP, Lucknow by which he has submitted supplementary/required information in connection with grant of permission to purchase semi finished house in Lucknow, having plot area 1010 sq. ft. (93.832 sq. meter), located in Arazi no. 294, village Khargpur, Lucknow.

In this connection, it is submitted that the officer through his letter dated 28.06.2018 (flag 'A') has requested for grant of permission to purchase semi finished house in Lucknow, having plot area 1010 sq. ft., located in Arazi no. 294, village Khargpur, Lucknow for a sum of Rs. 35,00,000/- from a private person. The matter was submitted before Hon'ble Mr. Justice Manoj Misra, vide detailed office note dated 12.07.2018 (flagged '2'), upon which His Lordship has been pleased to pass an order dated 25.07.2018, which is as follows:-

" As the property is located in Lucknow and is being purchased from a private person, the officer may be requested to provide the current circle rate of the area where the property is located."

The order was communicated to the officer vide Court's letter dated 28.07.2018 (flag '3'). The reply of the Court's letter dated 28.07.2018 has now been received.

In reply of the Court's letter dated 28.07.2018, Sri Singh vide his letter dated 30.07.2018 (flag '1'), has submitted that the proposed property situated in village Khargpur is in front of seven meter road and the circle rate of the area where the property is situated is Rs. 8,000/- per sq. m. He has also submitted copy of the circle rate list (flagged 'X').

In this connection, it is submitted that the officer has complied with the order of the Court by submitting the required details.
