May kindly see the letter dated 17.10.16 (flagged 'A' ) by which Sri Rajnesh Kumar, Additional Civil Judge(Sr.Div.), Saharanpur has submitted his movable and immovable property statement for the financial years 2011-12, 2012-13, 2013-14 and 2014-15.

Earlier Sri Rajnesh Kumar has submitted his movable property statements for the financial years from 2011-12 to 2014-15 vide his letter dated 16.8.16(flag 'B') but he has not submitted his immovable property statements for the aforesaid periods, hence a Court's letter dated 29.9.2016(flag 'C') has been sent to the officer in this regard.

In reply of aforesaid Court's letter, officer has submitted his immovable property statement for the aforesaid periods vide his letter dated 17.10.16 (flag 'A').

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2011-12, 2012-13, 2013-14 and 2014-15 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below.

(1) In the financial year 2011-12, Sri Rajnesh Kumar's Income from Salary and other Sources is 6,64,721(Rs.6,42,636/- is gross salary with allowances, Rs.7500 from Agriculture income, Rs.8340/- from interest of NSC; Rs.1600/- from Bank interest and Rs.4645/- from interest of PPF) from this amount Rs.2320/- is deducted against GIS, Rs.20,000/- against PPF, Rs.10,000/- against ICICI, Rs.13,200/- against Tution fees, Rs.15,800/- against NSC, Rs.73,057/- against CPF, Rs.88,000/- towards car loan and Rs.32,169/- against Income Tax. As such, total deductions /repayment/Savings/investment is Rs.2,54,546/-. The balance of his Saving Bank Account(s) has decreased for Rs.32,265/- in this year against the balance of previous year. Thus a sum of Rs.4,12,440/- was therefore available with him to meet out the household expenditure of his family consisting of four member in the financial year 2011-12.

(2) In the financial year 2012-13, Sri Rajnesh Kumar's Income from Salary and other Sources is Rs.7,23,563/- (Rs.6,62,279/- is gross salary with allowances, Rs.7500 from Agriculture income, Rs.10,313/- ~~8340~~ from interest of NSC, Rs.2079/- from Bank interest, Rs.6846/- from interest of PPF and Rs.34,546/- from T.A.) from this amount Rs.4800/- is deducted against GIS, Rs.30,000/- against PPF, Rs.10,000/- against ICICI, Rs.26,400/- against Tution fees, Rs.43,462/- against CPF, Rs.84,000/- towards car loan and Rs.28,882/- against Income Tax. As such, total deductions /repayment/Savings/investment is Rs.2,27,544/-. The balance of his Saving Bank Account(s) has decreased for Rs.93,765/- in this year against the balance of previous year. Thus a sum of Rs.5,89,784/- was therefore available with him to meet out the household expenditure of his family

consisting of four member in the financial year 2012-13.

(3) In the financial year 2013-14, Sri Rajnesh Kumar's Income from Salary and other Sources is Rs.10,14,741/- (Rs.9,47,845/- is gross salary with allowances, Rs.7500 from Agriculture income, Rs.11,155/- from interest of NSC, Rs.2,145/- from Bank interest, Rs.12,149/- from interest of PPF and Rs.33,947/- from arrears of Samptuary allowance) from this amount Rs.4800/- is deducted against GIS, Rs.50,000/- against PPF, Rs.10,000/- against ICICI, Rs.31,440/- against Tution fees, Rs.90,696/- against CPF, Rs.1,45,480/- towards car loan, Rs.2,000/- against P.M. Fund, Rs.35,630/- against PLI, and Rs.79,305/- against Income Tax. The balance of his Saving Bank Account(s) has enhanced for Rs.1,07,270/- in this year against the balance of previous year. As such, total deductions/ repayment /Savings/investment is Rs.5,56,621/-. Thus a sum of Rs.4,58,120/- was therefore available with him to meet out the household expenditure of his family consisting of four member in the financial year 2013-14.

(4) In the financial year 2014-15, Sri Rajnesh Kumar's Income from Salary and other Sources is Rs.9,70,590/- (Rs.8,14,888/- is gross salary with allowances, Rs.7500 from Agriculture income, ~~Rs.10,372~~ Rs.12,066/- from interest of NSC, Rs.2774/- from Bank interest, Rs.17,049/- from interest of PPF and Rs.53,313/- from surrendering of ICICI) from this amount Rs.4800/- is deducted against GIS, Rs.50,000/- against PPF, Rs.48,000/- against PLI, Rs.36,000/- against Tution fees, Rs.77,949/- against CPF, Rs.54,010/- towards car loan and Rs.56,176/- against Income Tax. The balance of his Saving Bank Account(s) has enhanced for Rs.1,73,233/- in this year against the balance of previous year. As such, total deductions/ repayment /Savings/investment is Rs.5,00,168/-. Thus a sum of Rs.4,70,422/- was therefore available with him to meet out the household expenditure of his family consisting of four member in the financial year 2014-15.

The movable and immovable property statement for the financial years 2011-12, 2012-13, 2013-14 and 2014-15 has been submitted by the officer vide his letter dated 16.8.16 (flagged 'B'). The property statements for the financial years 2011-12 and 2012-13 was due to be submitted in third financial years 2013-14, property statements for the financial years 2013-14 and 2014-15 was due to be submitted in third financial years 2015-16. As such there is delay in submitting the aforesaid Property statement from the part of officer for which officer has stated that delay caused due to heart problem of his mother and she succumbed to the heart attack on 23.4.15. Delay in this regard is highly regretted.

In this connection it is submitted last time Sri Rajnesh Kumar had already submitted his property statement for the financial year 2010-11 which had already been seen by Hon'ble Mr. Justice S.S.Chauhan, the then Administrative Judge, Budaun Judgeship on 10.1.13, which is at flag 'Z' and
