In her letters, ~~Mr.~~ ^{Smt} Sonal Pandey has stated that she wants to appear in the Civil Services Examination, 2011. She has, therefore, requested the Court to grant him permission to appear in the said examination.

In this connection, it is submitted that the officer has joined the U.P. Nyayik Sewa on 24-04-2009. It is desirable that she may be accorded permission to appear in preliminary examination of Civil Services Examination 2011 at present, if the Court so desires. Permission to appear in such type of preliminary examination may be accorded, but subject to the following conditions: -

- (1) Government work should not suffer in any way.
- (2) No preferential treatment will be given in the matter of leave, postings and transfer.
- (30) The permission can be withdrawn without notice if; it is found at any time that the government servant neglect ~~his~~ ^{her} normal work or that public work suffers, in any way.

May, therefore, if approved by Hon'ble Mr. Justice Satya Poot Mehrotra, Administrative Judge, Balrampur Judgeship, permission be accorded to ~~Mr.~~ ^{Smt.} Sonal Pandey, Judicial Magistrate, Balrampur to appear in preliminary examination of Civil Services Examination, 2011, as requested, subject to the conditions mentioned above?
