Vide aforesaid letter dated 28.02.2015, the District Judge, Hardoi has informed that Smt. Sonal Pandeya has not joined her duty since 04.08.12 and so directions given by the Hon'ble High Court has been issued to her through Registry letter. The Registry was served through A.D. but no message either telephonically or oral and in writing has been received to him. He has further stated that Smt. Sonal Pandeya has not contacted to the D.J., Office at all. The District judge has also enclosed the photocopy of Registered Post A.D. (Flags 'B') alongwith copy of report of Sadar Munsarim (Flags 'C').

In this context, it is pertinent to mention here that earlier vide endorsement no.1783/I-27-12 dated 03.08.12 (Flags 'D'), the District Judge, Hardoi forwarded the application of resignation dated nil of Km. Sonal Pandey in which She has stated that her marriage has been fixed recently and She has to join her husband for fulfilling her marital obligations. She has further stated that as her husband resides outside of this country, it is difficult for her to continue her employment in Uttar Pradesh Nyayik Sewa.

In this connection, it is submitted that vide Court's letter dated 20.09.2012 (Flags 'E'), the District Judge, Hardoi was requested to ask Km. Sonal Pandeya to send modified resignation/application after removing the objections raised by the above-mentioned Court's letter and the copy was also endorsed to Km. Sonal Pandeya but since then no reply with regard to modified resignation/application has been received to this Court till date.

Thereafter, vide Court's Reminder letter dated 03.02.15 (Flags 'F'), the District Judge, Hardoi was again requested to provide the requisite papers as required in the above-mentioned Court's letter in response to which the District Judge, Hardoi vide his letter dated 28.02.15 has provided the report that Smt.





“As per information Sushri Sonal Pandeya, Civil Judge (Jr. Div.) is on leave for about two years and she had also tendered resignation but till date no action has been taken against her absence which is against the rules, service condition, interest of the litigants and lawyers. Hence, firstly action is required to be taken regarding her absence for about two years. Let the matter be placed before Hon'ble the Chief Justice/appropriate committee for taking appropriate action. Secondly, step is required to be taken forthwith for appointment of any other Civil Judge (Jr. Div.) because apart from absence of Sushri Sonaly Pandeya, there are vacancies of two more Civil Judge (Jr. Div.).”

The order dated 18.12.2014 of Hon'ble the Administrative Judge, Hardoi passed on the office note dated 21.08.2014 is reproduced hereunder:

“As per report given by the District Judge, out of 26 total sanctioned strength, there are 22 Judicial Officers posted and are working. There are two vacant posts of Civil Judge (Jr. Div.) out of which the direction was issued by the High Court for posting of one Additional Civil Judge (Jr. Div.) as Presiding Officer of the Gram Nyayalaya at Tehsil Sandila District Hardoi. Apart from that Sushri Sonal Pandeya, Judicial Magistrate II/Civil Judge (Jr. Div.) is not working for last about two years but it is surprising that no action has been taken against her. Hence, there are four vacant post of Civil Judge (Jr. Div.) apart from vacant post of Additional District & Sessions Judge. Due to direction of the High Court for transfer of one of the Civil Judge (Jr. Div.) from Judgeship Hardoi as Presiding Officer at Tehsil Sandila, there are resentment among the members of the Bar of District Hardoi and they also proposed to go on strike. However, when I visited District Court Hardoi on 6th December 2014, they met me and I asked them not to observe strike. उपरोक्त विषयान्तर्गत सादर निवेदन है कि उत्तर प्रदेश सरकार की न्याय अनुभाग-2 (अधीनस्थ न्यायालय) अधिसूचना/विविध संख्या 1527/सात-न्याय-3-06-123 जी/01 टी0सी0-1, लखनऊ दिनांक 11.08.06 के अनुसार जनपद हरदोई में किशोर न्याय बोर्ड के प्रधान मजिस्ट्रेट के रूप में जिला हरदोई में नियुक्त वरिष्ठतम न्यायिक मजिस्ट्रेट कार्य करेंगे। वर्तमान में माननीय इलाहाबाद उच्च न्यायालय की स्थानान्तरण अधिसूचना संख्या 506/जे आर (एस)/2014 के अनुसार श्री ब्रिजेश कुमार एवं अधिसूचना संख्या 508/जे आर (एस)/2014 के अनुसार सुश्री सोनल पाण्डेय को न्यायिक मजिस्ट्रेट, हरदोई के रूप में नियुक्त किया गया है। सुश्री सोनल पाण्डेय श्री ब्रिजेश कुमार से वरिष्ठ हैं तथा इस प्रकार उत्तर प्रदेश सरकार की उक्त अधिसूचना के अनुसार सुश्री सोनल पाण्डेय ही किशोर न्याय बोर्ड के प्रधान मजिस्ट्रेट के रूप में कार्य करने के लिए अधिकृत हैं। यहां यह उल्लेखनीय है कि सुश्री सोनल पाण्डेय लगभग डेढ़ वर्ष से अधिक समय से जनपद हरदोई में कार्य नहीं कर ही है तथा उनके द्वारा दिया गया त्यागपत्र भी किन्ही कारणोंवश अभी तक स्वीकार नहीं किया गया है। उपरोक्त परिस्थिति में इस कार्यालय के पत्र संख्या 491/एक-36-98 दिनांक 11.04.14 (प्रति संलग्न) द्वारा माननीय न्यायालय से वर्तमान में जनपद में कार्यरत न्यायिक मजिस्ट्रेट श्री ब्रिजेश कुमार को किशोर न्याय बोर्ड, हरदोई में प्रधान मजिस्ट्रेट के रूप में कार्य करने की अनुमति प्रदान किए जाने हेतु दिशा-निर्देश चाहा गया है किन्तु अभी तक माननीय न्यायालय से इस संबंध में कोई दिशा-निर्देश प्राप्त न होने के कारण किशोर न्याय बोर्ड, हरदोई का कार्य प्रतिकूल रूप से प्रभावित हो रहा है।

अतः आपसे अनुरोध है कि किशोर न्याय बोर्ड, हरदोई में प्रधान मजिस्ट्रेट को नियुक्ति किए जाने संबंधी प्रश्नगत प्रकरण माननीय न्यायालय के समक्ष प्रस्तुत कर माननीय न्यायालय द्वारा प्रदान किए जाने वाले तत्संबंधी दिशा-निर्देशों से इस कार्यालय को अवगत कराने की कृपा करें।

In this connection it is submitted that Admin. 'A' Section of this Hon'ble Court, deal with the resignation matter of a Judicial Officer.

Therefore a report may be obtained from Admin. 'A' Section on the following points :-

- 1- Whether resignation moved by Sushri Sonal Pandeya has been accepted or not ?

May kindly see the requisition dated 03.07.2014 (at Flag 'A') of Joint Registrar (Services) regarding resignation matter of Sushri Sonal Pandeya.

If approved, the above information alongwith relevant papers in suport thereof in the matter may be sent to Joint Registrar (Services), for further necessary action, as desired?




