May kindly see the letter placed below at flag 'A' received from Sri Narendra Pal Rana, Additional Civil Judge(Jr.Div.), Nagina, Bijnor for grant of permission to join Post Graduate Diploma Course in 'Intellectual Property Rights' from National Law School, Bangalore through Correspondence.

In his letter, Sri Rana has stated that he wants to take admission to do Post Graduate Diploma Course in 'Intellectual Property Rights' from National Law School, Bangalore through correspondence. The course duration is one year and Course will not affect his Judicial work. As the date for applying for the same is 31.8.11, he has applying for the same in anticipation of permission. He has, therefore, requested to pursue the course.

In the instant case, it is to mention that the officer has joined the Judicial Service on 12.5.09. He wants to take admission to pursue Post Graduate Diploma Course in 'Intellectual Property Rights' from National Law School, Bangalore through correspondence. Acceptance of his request for taking admission in the Post Graduate Diploma Course in 'Intellectual Property Rights' from National Law School, Bangalore through correspondence may be considered as there appears to be no necessity to join any classes, but it is on the discretion of the Court. It is also submitted that a Judicial Officer can be accorded permission to attend academic classes and specialized higher studies in terms of G.O.No.24/1066-Appointment (B) dated 21.08.1967(copy at flag X), subject to the following conditions:-

- (1) Government work should not suffer in any way.
- (2) The academic classes are held outside office hours.
- (3) No preferential treatment will be given in the matter of leave, postings and transfer.
- (4) The permission can be withdrawn without notice if; it is found at any time that the government servant neglects his normal work or that public work suffers, in any way.

Under the facts and circumstances stated above, if approved, the file may kindly be laid before Hon'ble the Chief Justice for His Lordship's kind perusal and orders that Sri Narendra Pal Rana, Additional Civil Judge(Jr.Div.), Nagina, Bijnor may be accorded permission to pursue the Course of Post Graduate Diploma Course in 'Intellectual Property Rights' from National Law School, Bangalore through correspondence, as requested, subject to the conditions mentioned above?
