May kindly peruse the letter no. 114/XV dated 12.01.2018 of District Judge, Jhansi regarding issue direction/guideline about reimbursement of expenditure on Petrol by the Judicial Officer i.e. Sri Narendra Pal Rana and Smt. Manisha as Husband-Wife posted in Jhansi Judgeship.

In the instant letter dated 12.12.2018, the District Judge, Jhansi has stated that the Husband-Wife Judicial Officers i.e. Sri Narendra Pal Rana and Smt. Manisha have posted in his Judgeship and they had been moved an application separately for reimbursement of expenditure on Petrol as 50 Liter as per the Shetty Commission. The District Judge, Jhansi has requested to the Court that kindly issue the direction/guideline for the above subject.

In this regard, it is submitted that as per the G.O. No- 6058/do-4-05-45(12)/91 TC dated 27.01.2006 issued on the recommendation of the Shetty Commission, the Judicial Officers have an owned name registered private vehicle and they are used only in performing official duties then they have entitled for the reimbursement of expenditure on Petrol as 75 and 50 Liters respectively on the basis of expenditure certificate when they are posted in the A and A-1 categories cities or headquarters.

In view of the above, if approved, the District Judge, Jhansi be communicated that the Judicial Officers, who have posted in the same Judgeship and are also Husband-Wife, have entitled for reimbursement of expenditure on petrol after submitting the expenditure certificate as per the G.O. No- 6058/do-4-05-45(12)/91 TC dated 27.01.2006 issued on the recommendation of the Shetty Commission but for this, they should have the registration of the private vehicle in their name separately and to use separately private vehicle by them for only in performing official duties.
