May kindly see the letter, placed below at flag 'A', received from Km. Shagun Panwar, Addl. Civil Judge (Jr. Div.), Rampur for grant of permission to do LL.M. (two year's course) through correspondence from Kurukshetra University, Kurukshetra.

In her letter, Km. Shagun Panwar has stated that she has joined the judicial service on 20.04.2009 as Addl. Civil Judge (Jr. Div.), Rampur. She has applied to do LL.M. two year's course (session 2009-2011) through correspondence from Kurukshetra University, Kurukshetra, Haryana and to do the course, Court's permission is necessary. She has also stated that by doing the said course through correspondence, her judicial work will not suffer. She has, therefore, requested that her request for grant of permission to do the course of LL.M. through

In this connection it is submitted that Km. Shagun Panwar has joined the U.P. Nyayik Sewa on 20.04.2009. Her case may be considered as the course has to be done through correspondence and there appears to be no necessity to join any classes. However, acceptance of her request is on the discretion of the Court. It is also submitted that a judicial officer can be accorded permission to attend academic classes and specialized higher studies in terms of G.O.No. 24/1066-Appointment (B) dated 21.08.1967 (copy at flag X), subject to the following conditions: -

- (1) Government work should not suffer in any way.
- (2) The academic classes are held outside office hours.
- (3) No preferential treatment will be given in the matter of leave, postings and transfer.
- (4) The permission can be withdrawn without notice if; it is found at any time that the government servant neglects her normal work or that public work suffers, in any way.

A' Under the circumstances, if approved by Hon'ble the Chief Justice, Km. Shagun Panwar, Addl. Civil Judge (Jr. Div.), Rampur may be accorded permission to do LL.M. two year's course (session 2009-2011) through correspondence from Kurukshetra University, Kurukshetra, Haryana, as requested, subject to the conditions mentioned above?
