May kindly see the letters, placed below at flag 'A' & 'A-I', received from Km. Aanju Rajpoot, Civil Judge (Jr. Div.), Barabanki regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by her or any member of her family for the financial years 2009-10, 2010-11, 2011-12 & 2012-13 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that earlier Km. Anju Rajpoot had submitted his movable & immovable property statements for the financial years 2010-11, 2011-12 & 2012-13 through her letter dated 03-10-2015 (flagged 'A'). Thereafter she was asked to furnish some information vide Court's letters dated 21-11-2015 and 09-02-2016 (flagged 'C' & 'C-I').

Now, Km. Anju Rajpoot has submitted required informations through her letter dated 29-02-2016 (flagged 'A-I').

In this connection, it is submitted that as per statement of movable and immovable property for the financial year 2009-10, 2010-11, 2011-12, 2012-13, 2013-14 & 2014-15, of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

- (1) In the financial year 2009-10, the total income from salary of Km. Anju Rajpoot is Rs.2,52,714 for eleven months as she had joined that year on 20-04-2009, and from this amount Rs.1,320/- is deducted against GIS, Rs.5,00/- against Income Tax, Rs.12,000/- against LIC, Rs.15,000/- against Kodak Life policy and Rs.40,000/- deposited in his PPF account. The balance of his saving bank account (s) is enhanced to Rs.30,000/- from its previous year's balance. As such, total deductions/repayment/ 'savings/ investment is Rs.98,820/-. Thus, a sum of Rs.1,53,894/- was therefore available with her to meet out the household expenditure of her family consisting of one member in whole of the financial year 2009-10.
- (2) In the financial year 20/0-11, the total income from salary of Km. Anju Rajpoot is Rs.6,14,173, and from this amount Rs.1,440/- is deducted against GIS, Rs.75,986/- against CPF, Rs.27,540/- against Income Tax, Rs.12,000/- against LIC, Rs.15,000/- against Kodak Life policy and

Rs.20,000/- deposited in his PPF account. The balance of his saving bank account (s) is enhanced to Rs.1,26,000/- from its previous year's balance. As such, total deductions/repayment/savings/ investment is Rs.2,77,966/-. Thus, a sum of Rs.3,36,207/- was therefore available with her to meet out the household expenditure of her family consisting of one member in the financial year 2010-11.

- (3) In the financial year 2011-12, the total income from salary of Km. Anju Rajpoot is Rs.6,29,498, and from this amount Rs.1,440/- is deducted against GIS, Rs.54,660/- against CPF, Rs.27,935/- against Income Tax, Rs.12,000/- against LIC, Rs.15,000/- against Kodak Life policy, Rs.60,000/- against SBI life policy and Rs.40,000/- deposited in his PPF account. The balance of his saving bank account (s) is enhanced to Rs.1,71,836/- from its previous year's balance. As such, total deductions /repayment/savings/ investment is Rs.3,82,871/-. Thus, a sum of Rs.2,46,627/- was therefore available with her to meet out the household expenditure of her family consisting of one member in the financial year 2011-12.
- In the financial year 2012-13, the total income from salary and arrears is Rs.06,79,728/- and from this amount Rs.4,520/- is deducted against GIS, Rs.56,207/- against CPF, Rs.32,298/- against Income Tax, Rs.12,000/- against LIC and Rs.40,000/- deposited in his PPF account. As such, total deductions /repayment/savings/ investment is Rs.1,45,025/-. The balance of his saving bank account (s) is reduced to Rs.66,731/- from its previous year's balance. Thus, a sum of Rs.6,01,434/- was therefore available with her to meet out the household expenditure of her family consisting of one members in the financial year 2012-13.

In this connection it is submitted that last time, Km. Anju Rajpoot had submitted her property statement at the time of entering into Judicial service (statement is at flag 'M') which had already been seen by Hon'ble Mr. Justice V P. Pathak, the then Administrative Judge, Chitrakoot 21-05-2012 at flag 'Z'.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the years 2009-10 & 2010-11 in its next financial year i. e. in 2011-12 up to March 2012. She has submitted the complete property statements through her letter dated 03-10-2015 as such, there is delay in submitting the same statements. The property statement for the years 2011-12 & 2012-13 in its next financial year i. e. in 2013-14 up to March 2014. She has

submitted the same through her letter dated 03-10-2015 and as such, there is delay in submitting the same statements for the years 2011-12 and 2012-13. She could not the aforesaid property statement within time, for which she has regretted.

May, therefore, if approved, the property statements for the financial years 2009-10, 2010-11, 2011-12 & 2012-13, alongwith letters dated 03-10-2015 & 29-02-2016 (flagged 'A' & 'A-I') of Km. Aanju Rajpoot, Civil Judge (Jr. Div.), Barabanki be laid before Hon'ble Mr. Justice Pankaj Mithal, Administrative Judge, Barabanki Judgeship for His Lordship's kind perusal and orders?
