May kindly see the letter, placed below at **flag 'X-1'**, received from Km. Anju Rajpoot, the then Civil Judge (Jr. Div.), Barabanki now posted as Additional Civil Judge (Sr. Div.)/ Additional Chief Judicial Magistrate, Mathura by which she has furnished the reply, in compliance of order of Hon'ble Mr. Justice Pankaj Mithal, Administrative Judge, Lucknow in the matter of property statement for the financial year 2009-10, 2010-11, 2011-12 & 2012-13, communicated to the officer vide Court's letter dated 05.08.2016 (at **flag 'B'**).

In this connection, it is submitted that earlier Km. Anju Rajpoot had submitted her movable & immovable property statements for the financial years 2009-10 upto 2012-13, which was put up before Hon'ble the Administrative Judge, Barabanki through office note dated 29.04.2016 (at **flag 'Y'**). On which His Lordship has been pleased to pass the following order (at **flag 'YY'**):-

" The officer has sent income statement for the year 2009-10 upto 2012-13 together.

The practice of not sending the income statement timely is deprecated and the District Judge is directed to inform the officer that such delay in future would not be accepted.

Put up again after receiving the report from the officer."

The order of the Court had been communicated to the officer concerned vide Court's letter dated 05.08.2016 (at **flag 'B'**) and reminder letter dated 03.03.2017 (at **flag 'D'**) through the District Judge, Barabanki with the request to kindly intimate about the information of communication of the Court's order to Km. Anju Rajpoot, the then Civil Judge (Jr. Div.) Barabanki and in compliance of that report/ submission of the officer concerned, so that the report may be submitted before the Court, as per Court's order, for obtaining further order in the matter.

In reply of the Court's letter dated 03.03.2017, the District Judge,

Barabanki has replied vide his letter dated 15.03.2017 (at flag 'X'), that Court's order was communicated to Km. Anju Rajpoot on 09.08.2016, but in compliance of that the officer did not submitted the report, now the presiding officer has submitted her report (enclosed with the District Judge's letter) dated 09.03.2017 (at flag 'X-1') and the officer has stated in her report that she could not submit the statement of property within time and regretted for not submitting the report in compliance of Court's order due to forgetfulness. She has also most respectfully submit the report before the Hon'ble Court and prayed that the delay in submission of the same may kindly be condoned and in future she will be careful to submit her property statements in time.

During this tenure of time, Km. Anju Rajpoot through her letter dated 20.12.2016 (at flag 'G') has also submitted the statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by her or any member of her family for the financial years 2013-14 and 2014-15 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court and as per statement of movable and immovable property for the financial years 2013-14 and 2014-15 of the officer concerned, details of income, deductions, savings investment and expenditure made by her are given below.

(1) In the financial year 2013-14, the income from salary is Rs.8,64,499/- and from this amount, Rs.4,800/- is deducted against GIS, Rs.85,649/- against CPF, Rs.69,181/- against Income Tax, Rs.12,000/- against premium of LIC policies and Rs.61,000/- deposited in her PPF account. The balance of her savings bank account(s) enhanced for Rs.3,71,410/- this financial year from previous year's balance. As such, total deductions/ repayment/ savings/ investment is Rs.6,04,040/-. Thus, a sum of Rs.2,60,459/- was therefore available with her to meet out the household expenditure of herself in whole of the financial year.

(2) In the financial year 2014-15, the income from salary is Rs.8,39,913/-, and from this amount, Rs.4,800/- is deducted against GIS, Rs.76,872/-

against CPF, Rs.58,070/- against Income Tax, Rs.12,000/- against premium of LIC policies and Rs.1,40,000/- deposited in her PPF account. As such, total deductions/ repayment/ savings/ investment is Rs.2,91,742/-. The balance of her savings bank account(s) reduced for Rs.1,46,505/- this financial year from previous year's balance. Thus, a sum of Rs.6,94,676/- was therefore available with her to meet out the household expenditure of herself in whole of the financial year.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2013-14 & 2014-15 in its next financial year i.e., in 2015-16 up to March 2016. She has submitted the movable and immovable property statement for the financial year 2013-14 and 2014-15 vide his letter dated 20.12.2016 (at flag 'G'). As such, there is some delay in submitting the aforesaid statements.

May, therefore, if approved, letters/reply of Court's Order as desired by the Court in the matter, furnished by the officer dated 09.03.2017 (at flag 'X-1') through the District Judge, Barabanki dated 15.03.2017 (at flag 'X') alongwith the property statements for the financial years 2013-14 and 2014-15 submitted through letter dated 20.12.2016 (at flag 'G') of Km. Anju Rajpoot, Additional Civil Judge (Sr. Div.)/ Additional Chief Judicial Mgristrate, Mathura be laid before Hon'ble Mr. Justice Anil Kumar, Administrative Judge, Mathura for His Lordship's kind perusal and further orders?
