May kindly see the letter, placed below at **flag 'A'**, received from Sushri Anju Rajpoot, Additional Civil Judge (Sr. Div.), Mathura regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by her or any member of her family for the financial years 2015-16 and 2016-17 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2015-16 and 2016-17 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

- (1) In the financial year 2015-16, income from salary is Rs.9,54,851/- and from this amount, Rs.2,400/- is deducted against GIS, Rs.81,427/- against CPF, Rs.56,980/- against Income Tax, Rs.12,000/- against premium of LIC policy, Rs.7,700/- against NSC and Rs.1,40,000/- deposited in her PPF Account. The balance of her savings bank account(s) enhanced for Rs.2,56,427/- this financial year from last year's balance. As such, total deductions/ repayment/ savings/ investment is Rs.5,56,934/-. Thus, a sum of Rs.3,97,917/- was therefore available with her to meet out the household expenditure of herself in whole of the financial year.
- (2) In the financial year 2016-17, income from salary is Rs.9,94,290/- and from this amount, Rs.2,600/- is deducted against GIS, Rs.77,681/- against CPF, Rs.974/- against NPS(arrear), Rs.60,000/- against Income Tax, Rs.12,000/- against premium of LIC policy and Rs.90,000/- deposited in her PPF Account. The balance of her savings bank account(s) enhanced for Rs.4,19,854/- this financial year from last year's balance. As such, total deductions/ repayment/ savings/ investment is Rs.6,63,109/-. Thus, a sum of Rs.3,31,181/- was therefore available with her to meet out the household expenditure of herself in whole of the financial year.

In this connection it is submitted that Sushri Anju Rajpoot has already submitted her property statement upto the financial year 2014-15 (statement is at flag 'M') which had already been seen by Hon'ble Mr. Justice Anil Kumar, the then Administrative Judge, Mathura at flag 'Z'.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2015-16 & 2016-17 in its next

financial year i.e., 2017-18 upto March 2018. She has submitted the movable and immovable property statement for the financial year 2015-16 & 2016-17 vide her letter dated 23.07.2018 (at flag 'A').
