May kindly see the office note dated 6.12.06 at Flag 'M', regarding submission of movable and immovable property acquired/ held by Smt. Priti Singh, the then Civil Judge(Jr.Div.), Pratapgarh presently Addl. Chief Judicial Magistrate, Meerut for the Calendar Year 2002, 2003 as well as financial year 2004-05 and 2005-06 which was submitted before Hon'ble Mr. Justice Abdul Mateen , Administrative Judge, Pratapgarh for kind perusal and orders, on the perusal of the statement His Lordship has been pleased to order as under:-

The officer in her statement of immoveable properties for the year 2005-06 has mentioned acquisition of plot (240 Sq.m.) in Lucknow. It is further mentioned in her statement that the plot was purchased by obtaining loan from HDFC Bank, Lucknow amounting to Rs.8,38,440/-. In her statement of moveable properties for the year 2005-06 she has also mentioned sanction of loan to her by Punjab National Bank, Muzaffarpur amounting to Rs.3,40,000/- repayable in 72 installments. However, the officer has not mentioned the date of acquisition of plot in Lucknow, the locality of the plot and the Authority/Society from which the plot has been purchased. She be required to submit the following informations within one month.

- 1- Date of acquisition of plot.
2. Locality of the plot.
3. Authority/Society from which the plot has been purchased.
4. The monthly installments of the two loan amounts mentioned above.

**The file shall be placed before me immediately after one month."**

In response of the aforesaid Court's order, office has sent letters dated 12.12.07, 27.2.08 30.3.11 (flag 'B', 'C' and 'D') to the Officer with the request kindly to furnish the required information/papers to the Court within time.

In reply of aforesaid Court letter, officer has sent the required information to the Court vide his letter dated 26.4.11(at flag 'A-1') which are furnished herewith as per points of the order;

- (1) Date of allotment of plot is 31.8.2005 and date of acquisition of plot is not mentioned.
- (2) Locality of plot is Vrindavan Yogna - II.
- (3) Plot has been purchased from U.P. Avas Vikas Parishad
- (4) The monthly installments of Housing loan is Rs. 8225/month and monthly installment of Car loan is Rs.6,300/month.
