May kindly see the letter, placed below at flag 'A' received from Sri Durgesh, Civil Judge (Jr. Div.), Hapur ^(Ghaziabad) regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial years 2011-12 and 2012-13 in the prescribed proforma respectively to this Court, for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years ^{2011-12 and} 2012-13 ^{and} ~~2013-14~~ of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2011-12, the income from salary is Rs.05,71,490/- and from this amount, Rs.52,080/- is deducted against NPS, Rs.24,00/- against GIS, Rs.30,025/- against Income Tax, Rs.70,398/- against LIC premium Rs.48,036/- deposited against repayment of car loan. The balance of his savings bank account (s) enhanced for Rs.20,049/-(including interest). As such, total deductions/repayment /savings/ investment is Rs.2,22,988/- Thus, a sum of Rs.3,48,502/- was therefore available with him to meet out the household expenditure of his family consisting of five members in whole of the financial year 2011-12.

(2) In the financial year 2012-13, the income from salary is Rs.06,12,952/- and from this amount, Rs.2400/- is deducted against GIS, Rs.33,567/- against Income Tax, Rs.70,398/- against LIC premium, Rs.48,036/- deposited against repayment of car loan and Rs.1,00,000/- deposited in his PPF account. The balance of his savings bank account (s) enhanced for Rs.65,975/-(including interest). As such, total deductions/repayment /savings/ investment is Rs.3,20,376/- Thus, a sum of Rs.2,92,576/- was therefore available with him to meet out the household expenditure of his family consisting of five members in whole of the financial year 2012-13.
