Subject:- Permission applied by Km. Aparana Tripathi, Additional Civil Judge (Junior Division)/ Judicial Magistrate, Mirzapur for obtaining Passport.

Sir,

With reference to endt. no. 924/ I dated 30.05.2013 on the above subject, I have to say that Km. Aparana Tripathi, Additional Civil Judge (Junior Division)/ Judicial Magistrate, Mirzapur may kindly be asked to intimate her dependent family members as on date and, to **submit her declarations as per Section 6 (2) of the Passports Act, 1967, as well as following informations/ declarations, both on an 'Affidavit' :-**

- (a) that the applicant is a citizen of India;
- (b) that the applicant may not, or is not likely to, engage outside India in activities prejudicial to the sovereignty and integrity of India;
- (c) that the departure of the applicant from India may not, or is not likely to, be detrimental to the security of India;
- (d) that the presence of the applicant outside India may not, or is not likely to, prejudice the friendly relations of India with any foreign country;
- (e) that the applicant has, at any time during the period of five years immediately preceding the date of his application, not being convicted by a court in India for any offence involving moral turpitude and sentenced in respect thereof to imprisonment for not less than two years;
- (f) that proceedings in respect of any offence alleged to have not been committed by the applicant are pending before a criminal court in India;
- (g) that a warrant or summons for the appearance, or a warrant for the arrest, of the applicant has not been issued by a court under any law for the time being in force or that an order prohibiting the departure from India of the applicant has not been made by any such court;
- (h) that the applicant has not been repatriated.
- (I) Whether there is any possibility of arising embarrassing position before Government of U.P. due to her visit to any foreign country?
- (j) Whether issue of 'Identity Certificate' for obtaining a passport was ever

- (k) Whether she has visited any foreign country earlier and, if so, intimate details of the same.

Aparna Tripathi are to be submitted, out of which one photograph should be Identified/ certified by **yourself**, so that further necessary action regarding issuance of 'Identity Certificate' as per Annexure 'B' of 'Passport Application form/ Passport Information Booklet', for obtaining Passport by the officer, may be taken.
