May kindly see the letter dated 30.9.15 (at flag 'A') of Smt. Shivani Singh, Civil Judge(Jr.Div.), Allahabad by which she has submitted ^{her} ~~his~~ Statements of movable and immovable property for the financial years 2009-10, 2010-11, 2011-12 and 2012-13.

Earlier a Court letter dated 15.9.15(flag 'B') has been sent to the officer to send his property statement for the aforesaid periods.

In this connection, it is submitted that as per statements of movable and immovable property for the financial years 2009-10, 2010-11, 2011-12 and 2012-13, of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

(1) In the statement of movable and immovable property for the financial year 2009-10, Smt. Singh's gross Salary is Rs.2,33,172/- from this amount, she has paid Rs.1200/- against GIS, Rs.319/- against Income Tax, Rs.48528/- towards installments of loan, Rs.30.646/- against LIC.. As such, total deductions /Savings/investment is Rs.80,393/-. The balance of his Saving Bank Account(s) decreased for Rs.34546/- this financial year. Thus a sum of Rs.1,57,325/- was therefore available with her to meet out the household expenditure of her family consisting of only one member.

(2) In the statement of movable and immovable property for the financial year 2010-11, Smt. Singh's gross Salary is Rs.2,24,946/- from this amount, she has paid Rs.2994/- against CPF, Rs.2840/- against GIS, Rs.1668/- against Income Tax, Rs.48,528/- towards installments of loan, Rs.30.646/- against LIC. The balance of his Saving Bank Account(s) enhanced for Rs.10,022/- this financial year. As such, total deductions /Savings/investment is Rs.96,698/-. Thus a sum of Rs.1,28,248/- was therefore available with her to meet out the household expenditure of her family consisting of only one member.

(3) In the statement of movable and immovable property for the financial year 11-12, Smt. Singh's gross Salary is Rs.4,72,669/- from this amount, she has paid Rs.52,080/- against CPF, Rs.4800/- against GIS, Rs.16,000/- against Income Tax, Rs.1,72,440/- towards installments of loan, Rs.30,646/- against LIC and Rs.40,000/- against PPF. As such, total deductions /Savings/investment is Rs.3,15,966/-. The balance of his Saving Bank Account(s) decreased for Rs.9,988/- this financial year. Thus a sum of Rs.1,66,691/- was therefore available with her to meet out the household expenditure of her family consisting of two members.

(4) In the statement of movable and immovable property for the financial year 2012-13, Smt. Singh's gross Salary is Rs.7,04,798/- from this amount, she has paid Rs.46,289/- against CPF, Rs.2600/- against GIS, Rs.41,563/- against Income Tax, Rs.1,72,440/- towards installments of loans, Rs.30,646/- against LIC, Rs.15,000/- against PPF. The balance of his Saving Bank Account(s) enhanced for Rs.32,228/- this financial year. As such, total deductions /Savings/investment is Rs.3,40,766/-. Thus a sum of Rs.3,64,032/- was therefore available with her to meet out the household expenditure of her family consisting of ^{two} ~~only one~~ members.

The movable and immovable property statement for the financial years 2009-10, 2010-11, 2011-12 and 2012-13 has been submitted by the officer vide her letter dated 30.9.15 (flag 'A'). The Property Statements for the financial years 2009-10 and 2010-11 was due to be submitted in the financial year 2011-12 i.e. on or before 31.3.12 and Property Statements for the financial years 2011-12 and 2012-13 was due to be submitted in the financial year 2013-14 i.e. on or before 31.3.14 from the part of the officer for which officer has stated that due to oversight, burden of work

and certain personal matters, she could not submit property statement in preceding years and she apologies for the same.

It is pertinent to mention here that the husband of the officer Sri Anuj Kumar Singh, is Asst. Commandant in CRPF whose Salary is Rs.4,67,827/- (in the financial years 2011-12) and Rs.5,07,277/- (in the financial year 2012-13).

In this connection, it is submitted that Smt. Singh has already submitted her property statement of at the time of entering into Judicial Service which was seen by Hon'ble Mr. Justice Vineet Saran, the then Administrative Judge, Aligarh on 12.5.11 at flag 'Z' and the said statement is at flag 'M'.

May, if approved, the statements of movable and immovable property for the financial years 2009-10, 2010-11, 2011-12, 2012-13 of Smt. Shivani Singh, Civil Judge(Jr. Div.), Allahabad may kindly be laid before Hon'ble Mr. Justice Pankaj Mithal, Administrative Judge, Allahabad Judgeship for His Lordship's kind perusal and orders?
