May kindly see the letter dated 22.7.17 (at flag 'A') of Smt. Shivani Singh, Civil Judge(Sr.Div.), Amroha by which she has submitted her Statements of movable and immovable property for the financial years 2013-14, 2014-15, 2015-16 and 2016-17.

In this connection, it is submitted that as per statements of movable and immovable property for the financial years 2013-14, 2014-15, 2015-16 and 2016-17, of the officer concerned, details of income, deductions, Savings, investment and expenditure made by her are given below:-

(1) In the consolidated statement of movable and immovable property for the financial years 2013-14 & 2014-15, Smt. Singh's gross Salary is Rs.19,59,942/- from this amount, she has paid Rs.6400/- against GIS, Rs.1,31,635/- against CPF, Rs.1,73,738/- against Income Tax, Rs.74,000/- against PPF, Rs.61,292/- against LIC. The balance of his Saving Bank Account(s) enhanced for Rs.50,772/- this financial year against the balance of previous year. As such, total deductions /Savings/investment is Rs.4,97,837/-. Thus a sum of Rs.14,62,105/- was therefore available with her to meet out the household expenditure of her family consisting of three member.

(2) In the consolidated statement of movable and immovable property for the financial years 2015-16 and 2016-17, Smt. Singh's gross Salary is Rs.22,16,585/- from this amount, she has paid Rs.8,000/- against GIS, Rs.1,63,173/- against CPF, Rs.1,56,500/- against Income Tax, Rs.3,00,000/- against PPF, Rs.61,292/- against LIC. The balance of his Saving Bank Account(s) enhanced for Rs.3,11,837/- this financial year against the balance of previous year. As such, total deductions /Savings/investment is Rs.10,08,902/-. Thus a sum of Rs.12,07,683/- was therefore available with her to meet out the household expenditure of her family consisting of three member

The movable and immovable property statement for the financial years 2013-14, 2014-15, 2015-16 and 2016-17 has been submitted by the officer vide her letter dated 22.7.17 (flag 'A'). The Property Statements for the financial years 2013-14 and 2014-15 was due to be submitted in the financial year 2015-16 i.e. on or before 31.3.16 and Property Statements for the financial years 2015-16 and 2016-17 was due to be submitted in the financial year 2017-18 i.e. on or before 31.3.18. As such there is delay in submitting the property statements for the financial years 2013-14 and 2014-15 from the part of the officer for which officer has stated that due to oversight, burden of work and certain personal matters, she could not submit property statement in preceding years and she apologies for the same.

It is pertinent to mention here that the husband of the officer Sri Anuj Kumar Singh, is EPFO Asst Commissioner whose gross income is Rs.3,50,000/- annually (in the financial years 2013-14 & 2014-15) and joined Delhi Judicial Services on 15.9.15 after resigning from EPFO, and mentioned Rs.8,25,000/- annually(in the financial years 2015-16 and 2016-17).

In this connection, it is submitted that Smt. Singh has already submitted her property statement upto financial year 2012-13 which was seen by Hon'ble Mr. Justice Shashi Kant Gupta, the then Administrative Judge, Allahabad at flag 'Z' and
