May kindly see the letter dated 6.10.15 (at flag 'A') of Sri Rakesh Kumar Tiwari, Civil Judge(Jr.Div.), Unnao by which he has submitted his Statements of movable and immovable property for the financial years 2009-10, 2010-11, 2011-12, 2012-13, 2013-14 and 2014-15 in reply of Court letter dated 26.9.15(flag 'B').

In this connection, it is submitted that as per statements of movable and immovable property for the financial years 2009-10, 2010-11, 2011-12, 2012-13, 2013-14 and 2014-15 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

(1) In the statement of movable and immovable property for the financial year 2009-10, Sri Tiwari's Income from Salary is Rs.2,45,427/- from this amount, he has paid Rs.12,043/- against DCS, Rs.1200/- against GIS, Rs.400/- against Income Tax, Rs.48,040/- against LIC. The balance of his Saving Bank Account(s) enhanced for Rs.53,890/- this financial year. As such, total deductions /Savings/investment is Rs.1,15,573/-. Thus a sum of Rs.1,29,854/- was therefore available with him to meet out the household expenditure of his family consisting of two members in financial year 2009-10.

(2) In the statement of movable and immovable property for the financial year 2010-11, Sri Tiwari's Income from Salary is Rs.4,79,516/- from this amount, he has paid Rs.50,914/- against DCS, Rs.1440/- against GIS, Rs.18,000/- against Income Tax, Rs.48,040/- against LIC, Rs.60,000/- against PPF, Rs.20,000/- against Infra Bond. The balance of his Saving Bank Account(s) enhanced for Rs.1,06,609/- this financial year. As such, total deductions /Savings/investment is Rs.3,05,003/-. Thus a sum of Rs.1,74,513/- was therefore available with him to meet out the household expenditure of his family consisting of three members in financial year 2010-11.

(3) In the statement of movable and immovable property for the financial year 2011-12 Sri Tiwari's Income from Salary is Rs.6,54,280/- from this amount, he has paid Rs.66,097/- against DCS, Rs.1440/- against GIS, Rs.43,340/- against Income Tax, Rs.48,040/- against LIC, Rs.1,00,000/- against PPF, Rs.1,00,000/- against NSC, Rs.20,000/- against IDFC. The balance of his Saving Bank Account(s) enhanced for Rs.1,55,2210/- this financial year. As such, total deductions /Savings/investment is Rs.4,86,807/-. Thus a sum of Rs.1,67,473/- was therefore available with him to meet out the household expenditure of his family consisting of three members in financial year 2011-12.

(4) In the statement of movable and immovable property for the financial year 2012-13, Sri Tiwari's Income from Salary is Rs.7,17,302/- from this amount, he has paid Rs.31,800/- against DCS, Rs.2400/- against GIS, Rs.34,150/- against Income Tax, Rs.48,040/- against LIC, Rs.1,00,000/- against PPF, Rs.1,00,000/- against FDR. The balance of his Saving Bank Account(s) enhanced for Rs.1,07,738/- this financial year. As such, total deductions /Savings/investment is Rs.4,24,128/-. Thus a sum of Rs.2,93,174/- was therefore available with him to meet out the household expenditure of his family consisting of three members in financial year 2012-13.

(5) In the statement of movable and immovable property for the financial year 2013-14, Sri Tiwari's Income from Salary is Rs.8,18,166/- from this amount, he has paid Rs.92,129/- against DCS, Rs.2400/- against GIS, Rs.61,398/- against Income Tax, Rs.48,040/- against LIC, Rs.1,00,000/- against PPF. As such, total deductions /Savings/investment is Rs.3,03,967/-. The balance of his Saving Bank Account(s) decreased for Rs.27,311/- this financial year. Thus a sum of Rs.5,41,510/- was therefore available with him to meet out the household expenditure of his family consisting of

three members in financial year 2013-14.

(6) In the statement of movable and immovable property for the financial year 2014-15, Sri Tiwari's Income from Salary is Rs.8,67,806/- from this amount, he has paid Rs.80,093/- against DCS, Rs.2400/- against GIS, Rs.59,514/- against Income Tax, Rs.48,040/- against LIC, Rs.1,00,000/- against PPF and Rs.2,00,000/- against FD. As such, total deductions /Savings/investment is Rs.4,90,047/-. The balance of his Saving Bank Account(s) decreased for Rs.1,69,798/- this financial year. Thus a sum of Rs.5,39,554/- was therefore available with him to meet out the household expenditure of his family consisting of three members in financial year 2014-15.

The movable and immovable property statement for the financial years 2009-10, 2010-11, 2011-12, 2012-13, 2013-14 and 2014-15 has been submitted by the officer vide his letter dated 6.10.15 (flag 'A'). The Property Statements for the financial years 2009-10 and 2010-11 was due to be submitted in the financial year 2011-12 i.e. on or before 31.3.12, Property Statements for the financial years 2011-12 and 2012-13 was due to be submitted in the financial year 2013-14 i.e. on or before 31.3.14 and Property Statements for the financial years 2013-14 and 2014-15 was due to be submitted in the financial year 2015-16 i.e. on or before 31.3.16 As such there is delay in submitting the Property statements for the financial years 2009-10, 2010-11, 2011-12, 2012-13 from the part of the officer for which officer has stated that due to load of work, he was unable to submit the aforesaid statements in due time for which officer has regretted and further stated that the same will not be repeated in future.

In this connection, it is submitted that Sri Tiwari has already submitted his property statement of at the time of entering into Judicial Service which was seen by Hon'ble Mr. Justice R.R.Awasthi, the then Administrative Judge, BAhraich on 26.8.13 at flag 'Z' and the said statement is at flag 'M'.

May, if approved, the statements of movable and immovable property for the financial years 2009-10, 2010-11, 2011-12, 2012-13, 2013-14 and 2014-15 of Sri Rakesh Kumar Tiwari, Civil Judge(Jr.Div.), Unnao may kindly be laid before Hon'ble Mr. Justice Ritu Raj Awasthi, Administrative Judge, Unnao Judgeship for His Lordship's kind perusal and orders?
