May kindly see the letters, placed below at flag 'A' & A-1', received from Sri Kamlesh Kumar Maurya, Additional Civil Judge (Junior Division), Kanpur Dehat, regarding grant of permission to purchase a Revolver from Small Arms Factory, Kanpur.

In his letter at flag 'A', Sri Maurya had referred Circular letter no. 11/ IV h-16/ Admin (A) dated 12.04.2010 and had stated that prior to issuance of this Circular letter, he had applied for issuance of license of a Revolver on 22.03.2010 to the District Magistrate, Kanpur Nagar, copy of which is submitted (flag 'B'). He had, therefore, requested for grant of permission to purchase a Revolver. On receipt of his said letter, vide Court's letter dated 15.06.2010 (flag 'C'), he was asked to apply for grant of permission to purchase the firearm giving complete and pointwise information about purchase of the firearm, in the light of directions contained in Court's C.L. no. 25/ Admin (A) dated 13.07.1998. In reply of Court's letter dated 15.06.2010, he has now submitted his application as per requirement, giving the required details in his letter at flag 'A-1'. He has, therefore, requested the Court to grant him permission to purchase the firearm i.e. a Revolver.

It is submitted that as per Rule- 24 (2) of U.P. Government Servant's conduct (Amendment) Rule, 2002: -

"A Government servant who enters into any transaction concerning any movable property exceeding in value, the amount of his basic pay for one month, whether by way of purchase, sale or otherwise, shall forthwith report such transaction to the appropriate authority:

Provided that no Government servant shall inter into any such transaction except with or through a reputed dealer or agent of standing, or with the previous sanction of the appropriate authority."
