May kindly see the letter, placed below at flag 'A', received from Sri Raghuvir Singh Rathore, Judicial Magistrate, Ramabai Nagar (Kanpur Dehat) regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial years 2011-12, 2012-13, 2013-14 and 2014-15 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2011-12, 2012-13, 2013-14 and 2014-15 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2011-12, the income from salary is Rs.6,08,102/- and from this amount, Rs.2,160/- is deducted against GIS, Rs.30,240/- against Income Tax, Rs.53,866/- against CPF, Rs.23,913/- against premium of LIC policies, Rs. 25,000/- against RD and Rs. 30,143/- deposited in his PPF account. The balance of his savings bank account(s) enhanced for Rs. 29,672/- this financial year. As such, total deductions/ repayment/ savings/ investment is Rs.1,94,994/-. Thus, a sum of Rs.4,13,108/- was therefore available with him to meet out the household expenditure of his family consisting of five members in whole of the financial year.

(2) In the financial year 2012-13, the income from salary is Rs.7,72,479 and from this amount, Rs.4,800/- is deducted against GIS, Rs.58,386/- against Income Tax, Rs.30,193/- against Premium of LIC policies, Rs.60,000/- against RD and Rs.20,000/- deposited in his PPF account. As such, total deductions/ repayment/ savings/ investment is Rs.1,73,379/-. The balance of his savings bank account(s) reduced for Rs.2,104/- this financial year. Thus, a sum of Rs.6,01,204/- was therefore available with him to meet out the household expenditure of his family consisting of five members in whole of the financial year.

(3) In the financial year 2013-14, the income from salary is Rs.7,05,496/- and from this amount, Rs.4,800/- is deducted against GIS, Rs.35,000/- against Income Tax, Rs.40,245/- against CPF, Rs.54,489/- against Premium of LIC policies, Rs.60,000/- against RD and Rs.1,94,160 against House loan. As such, total deductions/ repayment/ savings/ investment is Rs.3,88,694/-. The balance of his savings bank account(s) reduced for Rs.69,437/- this financial year. Thus, a sum of Rs.3,86,239/- was therefore available with him to meet out the household expenditure of his family consisting of five members in whole of the financial year.

(4) In the financial year 2014-15, the income from salary is Rs.8,55,996 and income from sale of house is Rs.3,20,000/-. Thus, the total amount is Rs.11,75,996/- and from this amount, Rs.4,800/- is deducted against GIS, Rs.31,734/- against Income Tax, Rs.1,30,309/- against CPF, Rs.57,225/- against Premium of LIC policies, Rs.60,000/- against RD, Rs.1,68,000/- against House loan and Rs.40,000/- deposited in his PPF account. The balance of his savings bank account(s) enhanced for Rs.92,618/- this financial year. As such, total deductions/ repayment/ savings/ investment is Rs.5,84,686/-. Thus, a sum of Rs.5,91,310/- was therefore available with him to meet out the household expenditure of his family consisting of five members in whole of the financial year.

In this connection it is submitted that Sri Raghuvir Singh Rathore has already submitted his property statement upto the financial year 2010-11 (statement is at **flag 'M'**) which had already been seen by Hon'ble Mr. Justice Dilip Gupta, the then Administrative Judge, Jalaun at Orai on 13.03.2012 at **flag 'Z'**.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2011-12 & 2012-13 in its next financial year i.e., 2013-14 up to March 2014, and 2013-14 & 2014-15 in its next financial year i.e., 2015-16 up to March 2016. He has submitted the movable and immovable property statement for the financial year 2011-12, 2012-13, 2013-14 & 2014-15 vide his letter dated 02.11.2015. As such, there is delay in submitting the property statements for the financial year 2011-12 and 2012-13 from the part of

the officer for which he has highly apologize and stated that he could not submit it within time due to bona-fide mistake, in his letter dated 02.11.2015 (flag 'A').

May, therefore, if approved, the property statements for the financial years 2011-12, 2012-13, 2013-14 and 2014-15 alongwith letter dated 02.11.2015 (at flag 'A') of Sri Raghuvir Singh Rathore, Judicial Magistrate, Ramabai Nagar (Kanpur Dehat) be laid before Hon'ble Mr. Justice Anant Kumar, Administrative Judge, Ramabai Nagar Judgeship for His Lordship's kind perusal and orders?
